3 process.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 ARTICLE 1. ENTITIES GIVEN 2013 SUNSET DATE

6 SECTION 1.01. UNIVERSITY INTERSCHOLASTIC LEAGUE. Section
7 33.083, Education Code, is amended by adding Subsection (e) to read
8 as follows:

9 (e) The University Interscholastic League is subject to
10 review under Chapter 325, Government Code (Texas Sunset Act), but
11 is not abolished under that chapter. The University
12 Interscholastic League shall be reviewed during the period in which
13 state agencies abolished in 2013 are reviewed. The University
14 Interscholastic League shall pay the costs incurred by the Sunset
15 Advisory Commission in performing the review under this subsection.
16 The Sunset Advisory Commission shall determine the costs of the
17 review performed under this subsection, and the University
18 Interscholastic League shall pay the amount of those costs promptly
19 on receipt of a statement from the Sunset Advisory Commission
20 regarding those costs. This subsection expires September 1, 2013.

21 SECTION 1.02. TEXAS HIGHER EDUCATION COORDINATING BOARD.

22 Section 61.0211, Education Code, is amended to read as follows:

23 Sec. 61.0211. SUNSET PROVISION. The Texas Higher Education
24 Coordinating Board is subject to Chapter 325, Government Code

1 (Texas Sunset Act). Unless continued in existence as provided by
2 that chapter, the board is abolished and this chapter expires
3 September 1, 2013 [~~2015~~].

4 SECTION 1.03. TEXAS ETHICS COMMISSION. Section 571.022,
5 Government Code, is amended to read as follows:

6 Sec. 571.022. SUNSET PROVISION. The commission is subject
7 to review under Chapter 325 (Texas Sunset Act), but is not abolished
8 under that chapter. The commission shall be reviewed during the
9 periods in which state agencies abolished in 2013 [~~2015~~] and every
10 12th year after that year are reviewed.

11 SECTION 1.04. TEXAS WINDSTORM INSURANCE ASSOCIATION.
12 Section 2210.002(b), Insurance Code, is amended to read as follows:

13 (b) The association is subject to review under Chapter 325,
14 Government Code (Texas Sunset Act), but is not abolished under that
15 chapter. The association shall be reviewed during the period in
16 which state agencies abolished in 2013 [~~2015~~] are reviewed. The
17 association shall pay the costs incurred by the Sunset Advisory
18 Commission in performing the review of the association under this
19 subsection. The Sunset Advisory Commission shall determine the
20 costs of the review performed under this subsection, and the
21 association shall pay the amount of those costs promptly on receipt
22 of a statement from the Sunset Advisory Commission regarding those
23 costs. This subsection expires September 1, 2013 [~~2015~~].

24 SECTION 1.05. TEXAS STATE BOARD OF PUBLIC ACCOUNTANCY.
25 Section 901.006, Occupations Code, is amended to read as follows:

26 Sec. 901.006. APPLICATION OF SUNSET ACT. The Texas State
27 Board of Public Accountancy is subject to Chapter 325, Government

1 Code (Texas Sunset Act). Unless continued in existence as provided
2 by that chapter, the board is abolished and this chapter expires
3 September 1, 2013 [~~2015~~].

4 SECTION 1.06. TEXAS BOARD OF PROFESSIONAL ENGINEERS.
5 Section 1001.005, Occupations Code, is amended to read as follows:

6 Sec. 1001.005. APPLICATION OF SUNSET ACT. The Texas Board
7 of Professional Engineers is subject to Chapter 325, Government
8 Code (Texas Sunset Act). Unless continued in existence as provided
9 by that chapter, the board is abolished and this chapter expires
10 September 1, 2013 [~~2015~~].

11 SECTION 1.07. TEXAS BOARD OF ARCHITECTURAL EXAMINERS.
12 Section 1051.003, Occupations Code, is amended to read as follows:

13 Sec. 1051.003. APPLICATION OF SUNSET ACT. The Texas Board
14 of Architectural Examiners is subject to Chapter 325, Government
15 Code (Texas Sunset Act). Unless continued in existence as provided
16 by that chapter, the board is abolished and this subtitle expires
17 September 1, 2013 [~~2015~~].

18 SECTION 1.08. REGIONAL TOLLWAY AUTHORITIES. Subchapter B,
19 Chapter 366, Transportation Code, is amended by adding Section
20 366.039 to read as follows:

21 Sec. 366.039. SUNSET REVIEW. (a) An authority is subject
22 to review under Chapter 325, Government Code (Texas Sunset Act), as
23 if it were a state agency but may not be abolished under that
24 chapter. The review shall be conducted as if the authority were
25 scheduled to be abolished September 1, 2013.

26 (b) The authority shall pay the costs incurred by the Sunset
27 Advisory Commission in performing a review of the authority under

1 this section. The Sunset Advisory Commission shall determine the
2 costs, and the authority shall pay the amount promptly on receipt of
3 a statement from the Sunset Advisory Commission detailing the
4 costs.

5 SECTION 1.09. GULF COAST WATER AUTHORITY. Chapter 712,
6 Acts of the 59th Legislature, Regular Session, 1965, is amended by
7 adding Section 1A to read as follows:

8 Sec. 1A. The District is subject to review under Chapter
9 325, Government Code (Texas Sunset Act), but is not abolished under
10 that chapter. The District shall be reviewed during the period in
11 which state agencies abolished in 2013 are reviewed. The District
12 shall pay the costs incurred by the Sunset Advisory Commission in
13 performing the review of the District under this section. The
14 Sunset Advisory Commission shall determine the costs, and the
15 District shall pay the amount promptly on receipt of a statement
16 from the commission detailing the costs.

17 ARTICLE 2. ENTITIES GIVEN 2015 SUNSET DATE

23 is abolished September 1, 2015 [~~2013~~].

24 SECTION 2.02. OFFICE OF BANKING COMMISSIONER. Section
25 12.109, Finance Code, is amended to read as follows:

26 Sec. 12.109. SUNSET PROVISION. The office of banking
27 commissioner is subject to Chapter 325, Government Code (Texas
