- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 9 ARTICLE 1. GENERAL PROVISIONS RELATING TO PUC, ERCOT, AND OPUC
- SECTION 1.01. Section 12.005, Utilities Code, is amended to
- 11 read as follows:
- 12 Sec. 12.005. APPLICATION OF SUNSET ACT. The Public Utility
- 13 Commission of Texas is subject to Chapter 325, Government Code
- 14 (Texas Sunset Act). Unless continued in existence as provided by
- 15 that chapter or by Chapter 39, the commission is abolished and this
- 16 title expires September 1, 2023 [2011].
- SECTION 1.02. Section 12.155, Utilities Code, is amended by
- 18 adding Subsection (d) to read as follows:
- 19 (d) A commissioner may not be employed by an independent
- 20 organization certified under Section 39.151. The prohibition under
- 21 this subsection applies until the second anniversary of the date
- 22 the commissioner ceases to serve as a commissioner.
- SECTION 1.03. Section 13.002, Utilities Code, is amended to
- 24 read as follows:

- 1 Sec. 13.002. APPLICATION OF SUNSET ACT. The Office of
- 2 Public Utility Counsel is subject to Chapter 325, Government Code
- 3 (Texas Sunset Act). Unless continued in existence as provided by
- 4 that chapter, the office is abolished and this chapter expires
- 5 September 1, 2023 [2011].
- 6 SECTION 1.04. Section 15.023, Utilities Code, is amended by
- 7 amending Subsections (b), (c), and (d) and adding Subsection (b-1)
- 8 to read as follows:
- 9 (b) Except as provided by Subsection (b-1), the $[\frac{The}{T}]$
- 10 penalty for a violation may be in an amount not to exceed \$25,000.
- 11 Each day a violation continues or occurs is a separate violation for
- 12 purposes of imposing a penalty.
- 13 (b-1) The penalty for a violation of a reliability standard
- 14 adopted by the independent organization certified under Section
- 15 <u>39.151</u> or of a commission rule relating to reliability in the
- 16 wholesale electric market may be in an amount not to exceed
- 17 \$100,000. Each day a violation continues or occurs is a separate
- 18 violation for purposes of imposing a penalty.
- 19 (c) The commission by rule shall establish a classification
- 20 system for violations <u>described</u> by <u>Subsection</u> (b) and a <u>separate</u>
- 21 classification system for violations described by Subsection
- 22 (b-1). Each system must include [that includes] a range of
- 23 administrative penalties that may be assessed for each class of
- 24 violation, based on:
- 25 (1) the seriousness of the violation, including:
- 26 (A) the nature, circumstances, extent, and
- 27 gravity of a prohibited act; and

- 1 (B) the hazard or potential hazard created to the
- 2 health, safety, or economic welfare of the public;
- 3 (2) the economic harm to property or the environment
- 4 caused by the violation;
- 5 (3) the history of previous violations;
- 6 (4) the amount necessary to deter future violations;
- 7 (5) efforts to correct the violation; and
- 8 (6) any other matter that justice may require.
- 9 (d) The classification system established under Subsection
- 10 (c) shall provide that a penalty in an amount that exceeds \$5,000
- 11 may be assessed only if the violation is included in the highest
- 12 class of violations in the classification system. This subsection
- 13 does not apply to the classification system established under
- 14 Subsection (c) for a violation described by Subsection (b-1).
- 15 SECTION 1.05. Chapter 15, Utilities Code, is amended by
- 16 adding Subchapter D to read as follows:
- 17 SUBCHAPTER D. CEASE AND DESIST ORDERS
- 18 Sec. 15.101. APPLICATION OF SUBCHAPTER. This subchapter
- 19 applies only to a person to whom Subtitle B applies.
- Sec. 15.102. RULES. The commission shall adopt rules to
- 21 <u>implement this subchapter.</u>
- Sec. 15.103. PROCEEDINGS UNDER OTHER LAW. The commission
- 23 may proceed solely under this subchapter or under this subchapter
- 24 in conjunction with other applicable law.
- 25 Sec. 15.104. AUTHORITY TO ISSUE ORDER. (a) The
- 26 commission on its own motion may issue a cease and desist order:
- 27 (1) after providing notice and an opportunity for a

- 1 hearing if practicable or without notice or opportunity for a
- 2 hearing; and
- 3 (2) if the commission determines that the conduct of a
- 4 person:
- 5 (A) poses a threat to continuous and adequate
- 6 electric service;
- 7 <u>(B) is fraudulent;</u>
- 8 (C) is hazardous;
- 9 (D) creates an immediate danger to the public
- 10 safety; or
- 11 (E) is causing or can be reasonably expected to
- 12 cause an immediate injury to a customer of electric services and
- 13 that the injury is incapable of being repaired or rectified by
- 14 monetary compensation.
- 15 (b) The commission by order or rule may delegate to the
- 16 executive director the authority to issue cease and desist orders
- 17 under this subchapter.
- Sec. 15.105. NOTICE. (a) Notice of a proposed order must be
- 19 given not later than the 10th day before the date set for a hearing
- 20 if the commission requires notice and hearing before issuing the
- 21 <u>order.</u>
- 22 (b) On issuance of an order under Section 15.104 with or
- 23 without a hearing, the commission shall serve on the person
- 24 affected by the order an order that:
- 25 (1) contains a statement of the charges; and
- 26 (2) requires the person immediately to cease and
- 27 desist from the acts, methods, or practices stated in the order.

- 1 (c) The commission shall serve the order by registered or
- 2 certified mail, return receipt requested, to the person's last
- 3 known address.
- 4 Sec. 15.106. HEARING. (a) Chapter 2001, Government Code,
- 5 does not apply to the issuance of a cease and desist order under
- 6 this subchapter without a hearing. A hearing conducted before or
- 7 <u>after issuance of an order under this subchapter is a contested case</u>
- 8 under Chapter 2001, Government Code.
- 9 (b) Not later than the 10th day after the date the
- 10 commission issues an order under this subchapter without a hearing,
- 11 the commission shall set the time and place for a hearing to affirm,
- 12 modify, or set aside the order. The commission shall set the
- 13 hearing for a date that is not later than the 30th day after the date
- 14 the commission sets the time and place.
- 15 (c) At or following the hearing, the commission shall wholly
- or partly affirm, modify, or set aside the order.
- 17 (d) The commission may hold a hearing under this subchapter
- 18 or may authorize the State Office of Administrative Hearings to
- 19 hold the hearing.
- Sec. 15.107. EFFECT OF ORDER PENDING HEARING. Pending a
- 21 hearing under this subchapter, an order continues in effect unless
- 22 the order is stayed by the commission.
- Sec. 15.108. ADMINISTRATIVE PENALTY. The commission may
- 24 impose an administrative penalty under Subchapter B against a
- 25 person who violates an order issued under this subchapter.
- SECTION 1.06. Section 39.151, Utilities Code, is amended by
- 27 amending Subsections (d-1), (e), and (g) and adding Subsections

- 1 (d-2), (d-3), (d-4), (e-1), (g-2), (g-3), and (n) to read as
- 2 follows:
- 3 (d-1) The commission shall require an independent
- 4 organization certified by the commission under this section to
- 5 annually submit to the commission for review and approval the
- 6 organization's entire proposed annual budget. The commission may
- 7 approve, disapprove, or modify any item included in the proposed
- 8 budget. The commission by rule shall establish the type of
- 9 information or documents needed to effectively evaluate the
- 10 proposed budget and reasonable dates for the submission of that
- 11 information or those documents. The commission shall establish a
- 12 procedure to provide public notice of and public participation in
- 13 the budget review process.
- 14 (d-2) An independent organization certified by the
- 15 commission under this section must submit to the commission for
- 16 review and approval proposals for obtaining debt financing or for
- 17 refinancing existing debt. The commission may approve, disapprove,
- 18 or modify a proposal.
- 19 (d-3) An independent organization certified by the
- 20 commission under this section shall develop proposed performance
- 21 measures to track the organization's operations. The independent
- 22 organization must submit the proposed performance measures to the
- 23 commission for review and approval. The commission shall annually
- 24 review the organization's performance as part of the budget review
- 25 process under Subsection (d-1). The commission shall prepare an
- 26 annual report detailing the organization's performance and submit
- 27 the report to the lieutenant governor, the speaker of the house of

- 1 representatives, and each house and senate standing committee that
- 2 has jurisdiction over electric utility issues.
- 3 (d-4) The commission may:
- 4 (1) require an independent organization to provide
- 5 reports and information relating to the independent organization's
- 6 performance of the functions prescribed by this section and
- 7 relating to the organization's revenues, expenses, and other
- 8 financial matters;
- 9 (2) prescribe a system of accounts for an independent
- 10 organization;
- 11 (3) conduct audits of an independent organization's
- 12 performance of the functions prescribed by this section or relating
- 13 to its revenues, expenses, and other financial matters and may
- 14 require an independent organization to conduct such an audit;
- 15 (4) inspect an independent organization's facilities,
- 16 records, and accounts during reasonable hours and after reasonable
- 17 notice to the independent organization;
- 18 (5) assess administrative penalties against an
- 19 independent organization that violates this title or a rule or
- 20 order adopted by the commission and, at the request of the
- 21 commission, the attorney general may apply for a court order to
- 22 require an independent organization to comply with commission rules
- 23 and orders in the manner provided by Chapter 15; and
- 24 (6) resolve disputes between an affected person and an
- 25 independent organization and adopt procedures for the efficient
- 26 resolution of such disputes.
- 27 (e) After approving the budget of an independent

organization under Subsection (d-1), the [The] commission shall 1 [may] authorize the [an independent] organization [that is 2 certified under this section] to charge [a reasonable 3 competitively neutral rate] to wholesale buyers and sellers a 4 system administration fee, within a range determined by the 5 commission, that is reasonable and competitively neutral to fund 6 [to cover] the independent organization's approved budget [costs]. 7 8 commission shall investigate the organization's cost efficiencies, salaries and benefits, and use of debt financing and 9 10 may require the organization to provide any information needed to effectively evaluate [the organization's budget and] 11 12 reasonableness and neutrality of the fee [a rate or proposed rate] effectiveness efficiency of 13 evaluate the or 14 organization. - certification 1 (q) То maintain as an independent organization under this section, an organization's governing body 2 must be composed of persons specified by this section and selected 3 accordance with formal bylaws or protocols 4 organization. The bylaws or protocols must be approved by the 5 commission and must reflect the input of the commission. 6 bylaws must specify the process by which appropriate stakeholders 7 8 elect members and, for unaffiliated members, professional qualifications for selection as a member. - 19 require that an interexchange telecommunications utility, holder
- 20 of a certificate of operating authority, or holder of a service
- 21 provider certificate of operating authority file the information

- 23 article, once or on a regular basis. Regardless of the frequency of
- 24 filing required, each utility or holder shall file the information

- 6 Act if any element of the violation occurs before that date. A
- 7 violation that occurs before the effective date of this Act is
- 8 covered by the law in effect on the date the violation occurred, and
- 9 the former law is continued in effect for that purpose.
- 10 ARTICLE 2. WATER AND SEWER UTILITIES
- 11 SECTION 2.01. Section 13.002, Water Code, is amended by
- 12 amending Subdivisions (2) and (18) and adding Subdivision (22-a) to
- 13 read as follows:
- 14 (2) "Affiliated interest" or "affiliate" means:
- 15 (A) any person or corporation owning or holding
- 16 directly or indirectly five percent or more of the voting
- 17 securities of a utility;
- 18 (B) any person or corporation in any chain of
- 19 successive ownership of five percent or more of the voting
- 20 securities of a utility;
- (C) any corporation five percent or more of the
- 22 voting securities of which is owned or controlled directly or
- 23 indirectly by a utility;
- (D) any corporation five percent or more of the
- 25 voting securities of which is owned or controlled directly or
- 26 indirectly by any person or corporation that owns or controls
- 27 directly or indirectly five percent or more of the voting

- 1 securities of any utility or by any person or corporation in any
- 2 chain of successive ownership of five percent of those utility
- 3 securities;
- 4 (E) any person who is an officer or director of a
- 5 utility or of any corporation in any chain of successive ownership
- 6 of five percent or more of voting securities of a public utility;
- 7 (F) any person or corporation that the <u>utility</u>
- 8 commission, after notice and hearing, determines actually
- 9 exercises any substantial influence or control over the policies
- 10 and actions of a utility or over which a utility exercises such
- 11 control or that is under common control with a utility, such control
- 12 being the possession directly or indirectly of the power to direct
- 13 or cause the direction of the management and policies of another,
- 14 whether that power is established through ownership or voting of
- 15 securities or by any other direct or indirect means; or
- 16 (G) any person or corporation that the utility
- 17 commission, after notice and hearing, determines is exercising
- 18 substantial influence over the policies and actions of the utility
- 19 in conjunction with one or more persons or corporations with which
- 20 they are related by ownership or blood relationship, or by action in
- 21 concert, that together they are affiliated within the meaning of
- 22 this section, even though no one of them alone is so affiliated.
- 23 "Regulatory authority" means, in accordance with
- 24 the context in which it is found, either the commission, the utility
- 25 commission, or the governing body of a municipality.
- 26 (22-a) "Utility commission" means the Public Utility
- 27 Commission of Texas.

- 1 SECTION 2.02. Section 13.004, Water Code, is amended to
- 2 read as follows:
- 3 Sec. 13.004. JURISDICTION OF UTILITY COMMISSION OVER
- 4 CERTAIN WATER SUPPLY OR SEWER SERVICE CORPORATIONS. (a)
- 5 Notwithstanding any other law, the utility commission has the same
- 6 jurisdiction over a water supply or sewer service corporation that
- 7 the <u>utility</u> commission has under this chapter over a water and sewer
- 8 utility if the utility commission finds that the water supply or
- 9 sewer service corporation:
- 10 (1) is failing to conduct annual or special meetings
- 11 in compliance with Section 67.007; or
- 12 (2) is operating in a manner that does not comply with
- 13 the requirements for classifications as a nonprofit water supply or
- 14 sewer service corporation prescribed by Sections 13.002(11) and
- 15 (24).
- 16 (b) If the water supply or sewer service corporation
- 17 voluntarily converts to a special utility district operating under
- 18 Chapter 65, the utility commission's jurisdiction provided by this
- 19 section ends.
- SECTION 2.03. Section 13.011, Water Code, is amended to
- 21 read as follows:
- Sec. 13.011. EMPLOYEES. (a) The executive director of the
- 23 utility commission and the executive director of the commission,
- 24 subject to approval, as applicable, by the utility commission or
- 25 the commission, shall employ any engineering, accounting, and
- 26 administrative personnel necessary to carry out each agency's
- 27 powers and duties under this chapter.

- 21 operation of a line, plant, or system of any other retail public
- 22 utility, or furnishes, makes available, renders, or extends retail
- 23 water or sewer utility service to any portion of the service area of
- 24 another retail public utility that has been granted or is not
- 25 required to possess a certificate of public convenience and
- 26 necessity, the utility commission may issue an order prohibiting
- 27 the construction, extension, or provision of service or prescribing

- 1 terms and conditions for locating the line, plant, or system
- 2 affected or for the provision of the service.
- 3 SECTION 2.43. Section 13.253, Water Code, is amended to
- 4 read as follows:
- 5 Sec. 13.253. IMPROVEMENTS IN SERVICE; INTERCONNECTING
- 6 SERVICE. (a) After notice and hearing, the <u>utility</u> commission may:
- 7 (1) order any retail public utility that is required
- 8 by law to possess a certificate of public convenience and necessity
- 9 or any retail public utility that possesses a certificate of public
- 10 convenience and necessity and is located in an affected county as
- 11 defined in Section 16.341 to:
- 12 (A) provide specified improvements in its
- 13 service in a defined area if service in that area is inadequate or

- 10 (4) issue an emergency order, with or without a
- 11 hearing, under Section 13.041.
- 12 (b) If the utility commission has reason to believe that
- 13 improvements and repairs to a water or sewer service system are
- 14 necessary to enable a retail public utility to provide continuous
- 15 and adequate service in any portion of its service area and the
- 16 retail public utility has provided financial assurance under
- 17 Section 341.0355, Health and Safety Code, or under this chapter,
- 18 the utility commission, after providing to the retail public
- 19 utility notice and an opportunity to be heard by the commissioners
- 20 at a [commission] meeting of the utility commission, may
- 21 immediately order specified improvements and repairs to the water
- 22 or sewer system, the costs of which may be paid by the bond or other

- 25 lawfully interrogated, the <u>utility</u> commission may apply to any
- 26 court of competent jurisdiction to compel obedience by proceedings
- 27 for contempt.

- 1 SECTION 2.66. Section 13.418, Water Code, is amended to
- 2 read as follows:
- 3 Sec. 13.418. DISPOSITION OF FINES AND PENALTIES; WATER
- 4 UTILITY IMPROVEMENT ACCOUNT. (a) Fines and penalties collected
- 5 under this chapter from a retail public utility that is not a public
- 6 utility in other than criminal proceedings shall be [paid to the
- 7 commission and deposited in the general revenue fund.
- 8 (b) Fines and penalties collected from a public utility
- 9 under this chapter in other than criminal proceedings shall be
- 10 [paid to the commission and] deposited in the water utility
- 11 improvement account as provided by Section 341.0485, Health and
- 12 Safety Code.
- SECTION 2.67. Section 13.501(7), Water Code, is amended to
- 14 read as follows:
- 15 (7) "Multiple use facility" means commercial or
- 16 industrial parks, office complexes, marinas, and others
- 17 specifically identified in utility commission rules with five or
- 18 more units.
- 19 SECTION 2.68. Section 13.502(e), Water Code, is amended to
- 20 read as follows:
- (e) An owner of an apartment house, manufactured home rental
- 22 community, or multiple use facility or a manager of a condominium
- 23 may not change from submetered billing to allocated billing unless:
- 24 (1) the executive director of the utility commission
- 25 approves of the change in writing after a demonstration of good
- 26 cause, including meter reading or billing problems that could not
- 27 feasibly be corrected or equipment failures; and

- 1 (2) the property owner meets rental agreement
- 2 requirements established by the utility commission.
- 3 SECTION 2.69. Sections 13.503(a), (b), and (e), Water Code,
- 4 are amended to read as follows:
- 5 (a) The $\underline{\text{utility}}$ commission shall encourage submetering of
- 6 individual rental or dwelling units by master meter operators or
- 7 building owners to enhance the conservation of water resources.
- 8 Notwithstanding any other law, the utility commission shall adopt rules and standards under which an owner, operator, or 9 manager of an apartment house, manufactured home rental community, 10 or multiple use facility that is not individually metered for water 11 for each rental or dwelling unit may install submetering equipment 12 for each individual rental or dwelling unit for the purpose of 13 14 fairly allocating the cost of each individual rental or dwelling 15 unit's water consumption, including wastewater charges based on water consumption. In addition to other appropriate safeguards for 16 17 the tenant, the rules shall require that, except as provided by this section, an apartment house owner, manufactured home rental 18 19 community owner, multiple use facility owner, or condominium manager may not impose on the tenant any extra charges, over and 20 21 above the cost per gallon and any other applicable taxes and surcharges that are charged by the retail public utility to the 22 23 owner or manager, and that the rental unit or apartment house owner 24 or manager shall maintain adequate records regarding submetering 25 and make the records available for inspection by the tenant during reasonable business hours. The rules shall allow an owner or 26 manager to charge a tenant a fee for late payment of a submetered 27

- 1 water bill if the amount of the fee does not exceed five percent of
- 2 the bill paid late. All submetering equipment is subject to the
- 3 rules and standards established by the <u>utility</u> commission for
- 4 accuracy, testing, and record keeping of meters installed by
- 5 utilities and to the meter-testing requirements of Section 13.140
- 6 [of this code].
- 7 (e) The utility commission may authorize a building owner to
- 8 use submetering equipment that relies on integrated radio based
- 9 meter reading systems and remote registration in a building
- 10 plumbing system using submeters that comply with nationally
- 11 recognized plumbing standards and are as accurate as utility water
- 12 meters in single application conditions.
- 13 SECTION 2.70. Section 13.5031, Water Code, is amended to
- 14 read as follows:
- Sec. 13.5031. NONSUBMETERING RULES. Notwithstanding any
- 16 other law, the utility commission shall adopt rules and standards
- 17 governing billing systems or methods used by manufactured home
- 18 rental community owners, apartment house owners, condominium
- 19 managers, or owners of other multiple use facilities for prorating
- 20 or allocating among tenants nonsubmetered master metered utility
- 21 service costs. In addition to other appropriate safeguards for the
- 22 tenant, those rules shall require that:
- 23 (1) the rental agreement contain a clear written
- 24 description of the method of calculation of the allocation of
- 25 nonsubmetered master metered utilities for the manufactured home
- 26 rental community, apartment house, or multiple use facility;
- 27 (2) the rental agreement contain a statement of the

- 1 average manufactured home, apartment, or multiple use facility unit
- 2 monthly bill for all units for any allocation of those utilities for
- 3 the previous calendar year;
- 4 (3) except as provided by this section, an owner or
- 5 condominium manager may not impose additional charges on a tenant
- 6 in excess of the actual charges imposed on the owner or condominium
- 7 manager for utility consumption by the manufactured home rental
- 8 community, apartment house, or multiple use facility;
- 9 (4) the owner or condominium manager shall maintain
- 10 adequate records regarding the utility consumption of the
- 11 manufactured home rental community, apartment house, or multiple
- 12 use facility, the charges assessed by the retail public utility,
- 13 and the allocation of the utility costs to the tenants;
- 14 (5) the owner or condominium manager shall maintain
- 15 all necessary records concerning utility allocations, including
- 16 the retail public utility's bills, and shall make the records
- 17 available for inspection by the tenants during normal business
- 18 hours; and
- 19 (6) the owner or condominium manager may charge a
- 20 tenant a fee for late payment of an allocated water bill if the
- 21 amount of the fee does not exceed five percent of the bill paid
- 22 late.
- 23 SECTION 2.71. Section 13.505, Water Code, is amended to
- 24 read as follows:
- 25 Sec. 13.505. ENFORCEMENT. In addition to the enforcement
- 26 provisions contained in Subchapter K [of this chapter], if an
- 27 apartment house owner, condominium manager, manufactured home

- 1 rental community owner, or other multiple use facility owner
- 2 violates a rule of the utility commission regarding submetering of
- 3 utility service consumed exclusively within the tenant's dwelling
- 4 unit or multiple use facility unit or nonsubmetered master metered
- 5 utility costs, the tenant may recover three times the amount of any
- 6 overcharge, a civil penalty equal to one month's rent, reasonable
- 7 attorney's fees, and court costs from the owner or condominium
- 8 manager. However, an owner of an apartment house, manufactured
- 9 home rental community, or other multiple use facility or
- 10 condominium manager is not liable for a civil penalty if the owner
- 11 or condominium manager proves the violation was a good faith,
- 12 unintentional mistake.
- 13 SECTION 2.72. Section 13.512, Water Code, is amended to
- 14 read as follows:
- 15 Sec. 13.512. AUTHORITY TO ENTER INTO PRIVATIZATION
- 16 CONTRACTS. Any eligible city is authorized to enter into
- 17 privatization contracts if such action is recommended by the board
- 18 of utility trustees and authorized by the governing body of the
- 19 eligible city pursuant to an ordinance. Any privatization contract
- 20 entered into prior to the effective date of this Act is validated,
- 21 ratified, and approved. Each eligible city shall file a copy of its
- 22 privatization contract with the utility commission, for
- 23 information purposes only, within 60 days of execution or the
- 24 effective date of this Act, whichever is later.
- SECTION 2.73. Section 13.513, Water Code, is amended to
- 26 read as follows:
- Sec. 13.513. ELECTION BY ELIGIBLE CITY TO EXEMPT SERVICE

- 1 PROVIDER FROM <u>UTILITY</u> COMMISSION JURISDICTION. A service provider
- 2 shall not constitute a "water and sewer utility," a "public
- 3 utility," a "utility," or a "retail public utility" within the
- 4 meaning of Chapter 13 as a result of entering into or performing a
- 5 privatization contract, if the governing body of the eligible city
- 6 shall so elect by ordinance and provide notice thereof in writing to
- 7 the utility commission; provided, however, this provision shall
- 8 not affect the application of Chapter 13 to an eligible city itself.
- 9 Notwithstanding anything contained in this section, any service
- 10 provider who seeks to extend or render sewer service to any person
- 11 or municipality other than, or in addition to, an eligible city may
- 12 be a "public utility" for the purposes of Chapter 13 with respect to
- 13 such other person or municipality.
- SECTION 2.74. (a) On March 1, 2012, the following are
- 15 transferred from the Texas Commission on Environmental Quality to
- 16 the Public Utility Commission of Texas:
- 17 (1) the powers, duties, functions, programs, and
- 18 activities of the Texas Commission on Environmental Quality
- 19 relating to the economic regulation of water and sewer utilities,
- 20 including the issuance and transfer of certificates of convenience
- 21 and necessity, the determination of rates, and the administration
- 22 of hearings and proceedings involving those matters, under Chapter
- 23 13, Water Code, as provided by this article;
- 24 (2) any obligations and contracts of the Texas
- 25 Commission on Environmental Quality that are directly related to
- 26 implementing a power, duty, function, program, or activity
- 27 transferred under this article; and

- 1 (3) all property and records in the custody of the
- 2 Texas Commission on Environmental Quality that are related to a
- 3 power, duty, function, program, or activity transferred under this
- 4 article and all funds appropriated by the legislature for that
- 5 power, duty, function, program, or activity.
- 6 (b) The Texas Commission on Environmental Quality and the
- 7 Public Utility Commission of Texas shall enter into a memorandum of
- 8 understanding that:
- 9 (1) identifies in detail the applicable powers and
- 10 duties that are transferred by this article;
- 11 (2) establishes a plan for the identification and
- 12 transfer of the records, personnel, property, and unspent
- 13 appropriations of the Texas Commission on Environmental Quality
- 14 that are used for purposes of the commission's powers and duties
- 15 directly related to the regulation of water and sewer utilities
- 16 under Chapter 13, Water Code, as amended by this article; and
- 17 (3) establishes a plan for the transfer of all pending
- 18 applications, hearings, rulemaking proceedings, and orders
- 19 relating to the economic regulation of water and sewer utilities
- 20 under Chapter 13, Water Code, as amended by this article, from the
- 21 Texas Commission on Environmental Quality to the Public Utility
- 22 Commission of Texas.
- (c) The executive directors of the Texas Commission on
- 24 Environmental Quality and the Public Utility Commission of Texas
- 25 may agree in the memorandum of understanding under this section to
- 26 transfer to the Public Utility Commission of Texas any personnel of
- 27 the Texas Commission on Environmental Quality whose functions

- 1 predominantly involve powers, duties, obligations, functions, and
- 2 activities related to the regulation of water and sewer utilities
- 3 under Chapter 13, Water Code, as amended by this article.
- 4 (d) The Texas Commission on Environmental Quality and the
- 5 Public Utility Commission of Texas shall appoint a transition team
- 6 to accomplish the purposes of this section. The transition team
- 7 shall establish guidelines on how the two agencies will cooperate
- 8 regarding:
- 9 (1) meeting federal drinking water standards;
- 10 (2) maintaining adequate supplies of water;
- 11 (3) meeting established design criteria for
- 12 wastewater treatment plants;
- 13 (4) demonstrating the economic feasibility of
- 14 regionalization; and
- 15 (5) serving the needs of economically distressed
- 16 areas.
- 17 (e) A rule, form, policy, procedure, or decision of the
- 18 Texas Commission on Environmental Quality related to a power, duty,
- 19 function, program, or activity transferred under this article
- 20 continues in effect as a rule, form, policy, procedure, or decision
- 21 of the Public Utility Commission of Texas and remains in effect
- 22 until amended or replaced by that agency.
- 23 (f) The memorandum required by this section must be
- 24 completed by February 1, 2012.
- 25 (g) The Public Utility Commission of Texas and the Texas
- 26 Commission on Environmental Quality shall adopt rules to implement
- 27 the changes in law made by this article to Chapter 13, Water Code,

- 1 not later than September 1, 2012.
- 2 SECTION 2.75. (a) The Public Utility Commission of Texas
- 3 shall conduct a comparative analysis of the ratemaking authority of
- 4 the commission before the effective date of this Act and the
- 5 ratemaking authority of the commission after the transition
- 6 described in Section 2.74 of this article, to identify potential
- 7 for procedural standardization. The Public Utility Commission of
- 8 Texas shall issue a report of the analysis, with recommendations
- 9 regarding rate standardization, for consideration by the 83rd
- 10 Legislature.
- 11 (b) The Public Utility Commission of Texas shall prepare a
- 12 report describing staffing changes related to the transition
- 13 described in Section 2.74 of this article, including reductions in
- 14 staff that the commission may realize as a result of consolidated
- 15 functions. The Public Utility Commission of Texas shall submit the
- 16 report to the Legislative Budget Board and the governor with the
- 17 legislative appropriations request for the 2014-2015 biennium.
- 18 ARTICLE 3. EFFECTIVE DATE
- 19 SECTION 3.01. This Act takes effect September 1, 2011.
