- 2 relating to the state low income housing plan and report developed
- 3 by the Texas Department of Housing and Community Affairs.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subsection (c), Section 2306.072, Government
- 6 Code, is amended to read as follows:
- 7 (c) The report must include:
- 8 (1) a complete operating and financial statement of
- 9 the department;
- 10 (2) a comprehensive statement of the activities of the
- 11 department during the preceding year to address the needs
- 12 identified in the state low income housing plan prepared as
- 13 required by Section 2306.0721, including:
- 14 (A) a statistical and narrative analysis of the
- 15 department's performance in addressing the housing needs of
- 16 individuals and families of low and very low income;
- 17 (B) the ethnic and racial composition of
- 18 individuals and families applying for and receiving assistance from
- 19 each housing-related program operated by the department; [and]
- (C) the department's progress in meeting the
- 21 goals established in the previous housing plan, including goals
- 22 established with respect to the populations described by Section
- 23 2306.0721(c)(1); and
- 24 (D) recommendations on how to improve the

1 coordination of department services to the populations described by

- 2 Section 2306.0721(c)(1);
- 3 (3) an explanation of the efforts made by the
- 4 department to ensure the participation of individuals of low income
- 5 and their community-based institutions in department programs that
- 6 affect them;
- 7 (4) a statement of the evidence that the department
- 8 has made an affirmative effort to ensure the involvement of
- 9 individuals of low income and their community-based institutions in
- 10 the allocation of funds and the planning process;
- 11 (5) a statistical analysis, delineated according to
- 12 each ethnic and racial group served by the department, that
- 13 indicates the progress made by the department in implementing the
- 14 state low income housing plan in each of the uniform state service
- 15 regions;
- 16 (6) an analysis, based on information provided by the
- 17 fair housing sponsor reports required under Section 2306.0724 and
- 18 other available data, of fair housing opportunities in each housing
- 19 development that receives financial assistance from the department
- 20 that includes the following information for each housing
- 21 development that contains 20 or more living units:
- 22 (A) the street address and municipality or county
- 23 in which the property is located;
- 24 (B) the telephone number of the property
- 25 management or leasing agent;
- 26 (C) the total number of units, reported by
- 27 bedroom size;

- 1 (D) the total number of units, reported by
- 2 bedroom size, designed for individuals who are physically
- 3 challenged or who have special needs and the number of these
- 4 individuals served annually;
- 5 (E) the rent for each type of rental unit,
- 6 reported by bedroom size;
- 7 (F) the race or ethnic makeup of each project;
- 8 (G) the number of units occupied by individuals
- 9 receiving government-supported housing assistance and the type of
- 10 assistance received;
- 11 (H) the number of units occupied by individuals
- 12 and families of extremely low income, very low income, low income,
- 13 moderate income, and other levels of income;
- 14 (I) a statement as to whether the department has
- 15 been notified of a violation of the fair housing law that has been
- 16 filed with the United States Department of Housing and Urban
- 17 Development, the Commission on Human Rights, or the United States
- 18 Department of Justice; and
- (J) a statement as to whether the development has
- 20 any instances of material noncompliance with bond indentures or
- 21 deed restrictions discovered through the normal monitoring
- 22 activities and procedures that include meeting occupancy
- 23 requirements or rent restrictions imposed by deed restriction or
- 24 financing agreements;
- 25 (7) a report on the geographic distribution of low
- 26 income housing tax credits, the amount of unused low income housing
- 27 tax credits, and the amount of low income housing tax credits

- 1 received from the federal pool of unused funds from other states;
- 2 and
- 3 (8) a statistical analysis, based on information
- 4 provided by the fair housing sponsor reports required by Section
- 5 2306.0724 and other available data, of average rents reported by
- 6 county.
- 7 SECTION 2. Subsection (c), Section 2306.0721, Government
- 8 Code, is amended to read as follows:
- 9 (c) The plan must include:
- 10 (1) an estimate and analysis of the size and the
- 11 <u>different</u> housing needs of the following populations in each
- 12 uniform state service region:
- 13 (A) individuals and families of moderate, low,
- 14 very low, and extremely low income;
- 15 (B) individuals with special needs; [and]
- 16 (C) homeless individuals;
- 17 <u>(D) veterans;</u>
- 18 (E) farmworkers; and
- 19 (F) youth who are aging out of foster care;
- 20 (2) a proposal to use all available housing resources
- 21 to address the housing needs of the populations described by
- 22 Subdivision (1) by establishing funding levels for all
- 23 housing-related programs;
- 24 (3) an estimate of the number of federally assisted
- 25 housing units available for individuals and families of low and
- 26 very low income and individuals with special needs in each uniform
- 27 state service region;

- 1 (4) a description of state programs that govern the
- 2 use of all available housing resources;
- 3 (5) a resource allocation plan that targets all
- 4 available housing resources to individuals and families of low and
- 5 very low income and individuals with special needs in each uniform
- 6 state service region;
- 7 (6) a description of the department's efforts to
- 8 monitor and analyze the unused or underused federal resources of
- 9 other state agencies for housing-related services and services for
- 10 homeless individuals and the department's recommendations to
- 11 ensure the full use by the state of all available federal resources
- 12 for those services in each uniform state service region;
- 13 (7) strategies to provide housing for individuals and
- 14 families with special needs in each uniform state service region;
- 15 (8) a description of the department's efforts to
- 16 encourage in each uniform state service region the construction of
- 17 housing units that incorporate energy efficient construction and
- 18 appliances;
- 19 (9) an estimate and analysis of the housing supply in
- 20 each uniform state service region;
- 21 (10) an inventory of all publicly and, where possible,
- 22 privately funded housing resources, including public housing
- 23 authorities, housing finance corporations, community housing
- 24 development organizations, and community action agencies;
- 25 (11) strategies for meeting rural housing needs;
- 26 (12) a biennial action plan for colonias that:
- 27 (A) addresses current policy goals for colonia

- 1 programs, strategies to meet the policy goals, and the projected
- 2 outcomes with respect to the policy goals; and
- 3 (B) includes information on the demand for
- 4 contract-for-deed conversions, services from self-help centers,
- 5 consumer education, and other colonia resident services in counties
- 6 some part of which is within 150 miles of the international border
- 7 of this state;
- 8 (13) a summary of public comments received at a
- 9 hearing under this chapter or from another source that concern the
- 10 demand for colonia resident services described by Subdivision (12);
- 11 and
- 12 (14) any other housing-related information that the
- 13 state is required to include in the one-year action plan of the
- 14 consolidated plan submitted annually to the United States
- 15 Department of Housing and Urban Development.
- SECTION 3. This Act takes effect immediately if it receives
- 17 a vote of two-thirds of all the members elected to each house, as
- 18 provided by Section 39, Article III, Texas Constitution. If this
- 19 Act does not receive the vote necessary for immediate effect, this
- 20 Act takes effect September 1, 2011.
