A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Northern Dallam County Groundwater
3	Conservation District; providing authority to impose a tax and
4	issue bonds.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle H, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8853 to read as follows:
8	CHAPTER 8853. NORTHERN DALLAM COUNTY GROUNDWATER
9	CONSERVATION DISTRICT
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8853.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the board of directors of the
13	district.
14	(2) "Director" means a board member.
15	(3) "District" means the Northern Dallam County
16	Groundwater Conservation District.
17	Sec. 8853.002. NATURE OF DISTRICT. The district is a
18	groundwater conservation district created under and essential to
19	accomplish the purposes of Section 59, Article XVI, Texas
20	Constitution.
21	Sec. 8853.003. LEGISLATIVE FINDINGS. (a) The district is
22	created to serve a public use and benefit.
23	(b) All land and other property in the district will benefit
24	from the works and projects that are to be accomplished by the

district under this chapter. 1 2 (c) Any fees imposed by the district are necessary to pay 3 for the costs of accomplishing district purposes, including the conservation and management of groundwater resources, as provided 4 by this chapter and Section 59, Article XVI, Texas Constitution. 5 Sec. 8853.004. INITIAL DISTRICT TERRITORY. 6 (a) The 7 district is initially composed of the territory described by Section 2 of the Act enacting this chapter, except that the 8 9 territory does not include any territory that was added to the North Plains Groundwater Conservation District before the effective date 10 11 of the Act enacting this chapter. (b) The boundaries and field notes contained in Section 2 of 12 13 the Act enacting this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process 14 15 does not affect the district's: 16 (1) organization, existence, or validity; (2) right to issue any type of bond for the purposes 17 18 for which the district is created or to pay the principal of and interest on a bond; 19 20 (3) right to impose a tax; or 21 (4) legality or operation. 22 [Sections 8853.005-8853.020 reserved for expansion] SUBCHAPTER A-1. TEMPORARY PROVISIONS 23 Sec. 8853.021. APPOINTMENT OF TEMPORARY 24 DIRECTORS. 25 (a) Not later than the 30th day after the effective date of this

chapter, the Dallam County Commissioners Court shall appoint six

temporary directors to represent the district at large.

- 1 (b) To be eligible to serve as a temporary director, a
- 2 person must be a registered voter in Dallam County.
- 3 (c) Temporary directors serve until the date initial
- 4 directors are elected under Section 8853.023.
- 5 Sec. 8853.022. ORGANIZATIONAL MEETING OF TEMPORARY
- 6 DIRECTORS. As soon as practicable after all the temporary
- 7 directors have qualified under Section 36.055, Water Code, a
- 8 majority of the temporary directors shall convene the
- 9 organizational meeting of the district at a location in the
- 10 district agreeable to a majority of the directors. If an agreement
- 11 on location cannot be reached, the organizational meeting shall be
- 12 at the Dallam County Courthouse.
- 13 Sec. 8853.023. INITIAL DIRECTORS' ELECTION. (a) The
- 14 temporary directors shall hold an election to elect the initial
- 15 directors of the district.
- 16 (b) The temporary directors shall have placed on the ballot
- 17 the names of all candidates for an initial director's position who
- 18 have filed an application for a place on the ballot as provided by
- 19 Section 52.003, Election Code.
- 20 (c) Section 41.001(a), Election Code, does not apply to an
- 21 election held under this section.
- 22 (d) Except as provided by this section, an election under
- 23 this section must be conducted as provided by Sections
- 24 36.017(b)-(i), Water Code, and the Election Code. The provision of
- 25 Section 36.017(d), Water Code, relating to the election of
- 26 permanent directors does not apply to an election under this
- 27 section.

- 1 Sec. 8853.024. INITIAL DIRECTORS. (a) The six initial
- 2 directors of the district serve on the board until permanent
- 3 directors are elected under Section 8853.055. The six initial
- 4 directors shall be elected from the district at large.
- 5 (b) The six initial directors shall draw lots to determine
- 6 which three directors serve a term expiring June 1 following the
- 7 first regularly scheduled election of directors under Section
- 8 8853.055 and which three directors serve a term expiring June 1
- 9 following the second regularly scheduled election of directors.
- 10 Sec. 8853.025. EXPIRATION OF SUBCHAPTER. This subchapter
- 11 expires September 1, 2012.
- 12 [Sections 8853.026-8853.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 8853.051. DIRECTORS; TERMS. (a) The district is
- 15 governed by a board of six directors.
- 16 (b) Directors serve staggered four-year terms, with two or
- 17 three directors' terms expiring June 1 of each even-numbered year.
- 18 (c) A director may serve not more than two consecutive
- 19 terms. A director may serve a third or subsequent term if the
- 20 director has not served in the preceding four years.
- Sec. 8853.052. METHOD OF ELECTING DIRECTORS. The directors
- 22 of the district are elected as follows:
- 23 (1) three directors from Area A, as described by
- 24 Section 2 of the Act enacting this chapter; and
- 25 (2) three directors from Areas B and C, as described by
- 26 Section 2 of the Act enacting this chapter.
- Sec. 8853.053. ADDITIONAL ELIGIBILITY TO VOTE FOR PROPERTY

- 1 OWNERS. A person who owns property in the district is not required
- 2 to reside in the territory of the district as required by Section
- 3 11.001(a)(2), Election Code, to be eligible to vote in a district
- 4 election.
- 5 Sec. 8853.054. DIRECTOR ELIGIBILITY; QUALIFICATION.
- 6 (a) To be eligible to serve as a director a person must be:
- 7 (1) a registered voter; or
- 8 (2) a property owner in the area described by Section 2
- 9 of the Act enacting this chapter that the person seeks to represent.
- 10 (b) Each director must qualify to serve in the manner
- 11 provided by Section 36.055, Water Code.
- 12 Sec. 8853.055. ELECTION DATE. The district shall hold an
- 13 election to elect the appropriate number of directors on the
- 14 uniform election date prescribed by Section 41.001, Election Code,
- 15 in May of each even-numbered year.
- Sec. 8853.056. VACANCIES. If a vacancy occurs on the board,
- 17 the Commissioners Court of Dallam County shall appoint a person who
- 18 is qualified under Section 8853.054 to fill the vacancy for the
- 19 unexpired term.
- 20 Sec. 8853.057. COMPENSATION. (a) Sections 36.060(a),
- 21 (b), and (d), Water Code, do not apply to the district.
- 22 (b) A director is entitled to receive compensation of not
- 23 more than \$50 a day for each day the director performs the duties of
- 24 a director. The compensation may not exceed \$3,000 a year.
- 25 (c) A director is entitled to receive reimbursement for the
- 26 director's reasonable expenses incurred while engaging in
- 27 activities on behalf of the district.

- 2 <u>SUBCHAPTER C. POWERS AND DUTIES</u>
- 3 Sec. 8853.101. GROUNDWATER CONSERVATION DISTRICT POWERS
- 4 AND DUTIES. Except as otherwise provided by this chapter, the
- 5 district has the powers and duties provided by the general law of
- 6 this state, including Chapter 36, Water Code, applicable to
- 7 groundwater conservation districts created under Section 59,
- 8 Article XVI, Texas Constitution.
- 9 Sec. 8853.102. APPLICABILITY OF DISTRICT RULES REGULATING
- 10 GROUNDWATER. District rules regulating groundwater adopted under
- 11 this chapter apply to all persons except as exempted under Section
- 12 36.117, Water Code, or this chapter.
- 13 Sec. 8853.103. CONTRACTS. The district may contract with
- 14 any person, public or private, for any district purpose.
- 15 Sec. 8853.104. REGISTRATION AND REPORTING REQUIREMENTS FOR
- 16 CERTAIN EXEMPT WELLS. The district may adopt rules that require the
- owner or operator of a well or class of wells exempt from permitting
- 18 under Section 36.117, Water Code, to register the well with the
- 19 district and, except for a well exempt from permitting under
- 20 Section 36.117(b)(1), to report groundwater withdrawals from the
- 21 well using reasonable and appropriate reporting methods and
- 22 frequency.
- Sec. 8853.105. PROHIBITION ON DISTRICT PURCHASE, SALE,
- 24 TRANSPORT, OR DISTRIBUTION OF WATER. The district may not
- 25 purchase, sell, transport, or distribute surface water or
- 26 groundwater for any purpose.
- Sec. 8853.106. NO EMINENT DOMAIN POWER. The district may

not exercise the power of eminent domain. 1 Sec. 8853.107. ENFORCEMENT. (a) The district may enforce 2 this chapter as provided by Chapter 36, Water Code, and this 3 4 section. 5 (b) In addition to or instead of a remedy under Chapter 36, the district may impose an additional fee under Section 8853.151 on 6 7 a person producing groundwater in violation of a district rule or order, including the failure or refusal to comply with a rule or 8 9 order to reduce or cease groundwater usage. 10 (c) The fee imposed may not exceed an amount equal to 10 times the amount of a fee imposed under Section 8853.151. 11 [Sections 8853.108-8853.150 reserved for expansion] 12 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS 13 Sec. 8853.151. FEES. (a) The board by rule may impose 14 15 reasonable fees on each well: 16 (1) for which a permit is issued by the district; and 17 (2) that is not exempt from district regulation. 18 (b) A production fee may be based on: (1) the size of column pipe used by the well; or 19 the amount of water actually withdrawn from the 20 (2) well, or the amount authorized or anticipated to be withdrawn. 21 22 (c) The board shall base the initial production fee on the criteria listed in Subsection (b)(2). The initial production fee: 23 24 (1) may not exceed: 25 (A) \$1 per acre<u>-foot for water used</u> for agricultural irrigation; or 26

(B) 4.25 cents per thousand gallons for water

1 used for any other purpose; and 2 (2) may be increased at a cumulative rate not to exceed three percent per year. 3 4 (d) In addition to the production fee authorized under this 5 section, the district may assess an export fee on groundwater from a well that is produced for transport outside the district. 6 7 (e) Fees authorized by this section may be: 8 (1) assessed annually; 9 (2) used to pay the cost of district operations; and (3) used for any other purpose allowed under Chapter 10 11 36, Water Code. Sec. 8853.152. AD VALOREM TAX RATE. The district may not 12 13 impose ad valorem taxes at a rate that exceeds 1.5 cents on each 14 \$100 valuation of taxable property in the district. Sec. 8853.153. BOND DEBT LIMIT. The total debt created by 15 16 the issuance of bonds and notes by the district under Subchapter F, Chapter 36, Water Code, may not exceed \$500,000 at any time. 17 18 [Sections 8853.154-8853.200 reserved for expansion] SUBCHAPTER E. LANDOWNER OPTION TO JOIN DISTRICT 19 Sec. 8853.201. APPLICABILITY OF SUBCHAPTER. 20 This subchapter applies to a landowner who owns land that includes a 21 portion of the boundary between the North Plains Groundwater 22 23 Conservation District and the district. Sec. 8853.202. PETITION. (a) Not later than the first 24 25 anniversary of the effective date of the Act creating this chapter,

a landowner may petition the Texas Commission on Environmental

Quality to remove the land from the North Plains Groundwater

- 1 Conservation District and add the land to the district.
- 2 (b) The Texas Commission on Environmental Quality shall
- 3 grant the petition.
- 4 Sec. 8853.203. EXPIRATION OF SUBCHAPTER. This subchapter
- 5 expires on the first anniversary of the effective date of the Act
- 6 creating this chapter.
- 7 SECTION 2. Except as provided by Subchapter E, Chapter
- 8 8853, Special District Local Laws Code, as added by this Act, the
- 9 Northern Dallam County Groundwater Conservation District initially
- 10 includes all the territory contained in the following area:

- 11 SECTION 3. As soon as practicable, the North Plains
- 12 Groundwater Conservation District shall submit a metes and bounds
- 13 description of the territory described by Section 2 of this Act that
- 14 has been added to the North Plains Groundwater Conservation
- 15 District before the effective date of this Act to the:
- 16 (1) Northern Dallam County Groundwater Conservation
- 17 District; and
- 18 (2) Texas Commission on Environmental Quality.
- 19 SECTION 4. (a) The legal notice of the intention to
- 20 introduce this Act, setting forth the general substance of this
- 21 Act, has been published as provided by law, and the notice and a
- 22 copy of this Act have been furnished to all persons, agencies,
- 23 officials, or entities to which they are required to be furnished
- 24 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 25 Government Code.
- 26 (b) The governor has submitted the notice and Act to the
- 27 Texas Commission on Environmental Quality.

- 1 (c) The Texas Commission on Environmental Quality has filed
- 2 its recommendations relating to this Act with the governor,
- 3 lieutenant governor, and speaker of the house of representatives
- 4 within the required time.
- 5 (d) All requirements of the constitution and laws of this
- 6 state and the rules and procedures of the legislature with respect
- 7 to the notice, introduction, and passage of this Act are fulfilled
- 8 and accomplished.
- 9 SECTION 5. This Act takes effect immediately if it receives
- 10 a vote of two-thirds of all the members elected to each house, as
- 11 provided by Section 39, Article III, Texas Constitution. If this
- 12 Act does not receive the vote necessary for immediate effect, this
- 13 Act takes effect September 1, 2011.
