- 4 (b) Not later than September 1, 2011, the Texas Commission
- 5 on Environmental Quality shall reissue Permit No. 2925A, as amended
- 6 by Subsection (a) of this section.
- 7 SECTION 3. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2011.
