S.B. No. 1303

A BILL TO BE ENTITLED

AN ACT

1
2 relating to nonsubstantive additions to and corrections in enacted
3 codes, to the nonsubstantive codification or disposition of various
4 laws omitted from enacted codes, and to conforming codifications
5 enacted by the 81st Legislature to other Acts of that legislature.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 ARTICLE 1. GENERAL PROVISIONS

8 SECTION 1.001. This Act is enacted as part of the state's
9 continuing statutory revision program under Chapter 323,
10 Government Code. This Act is a revision for purposes of Section 43,
11 Article III, Texas Constitution, and has the purposes of:

12 (1) codifying without substantive change or providing
13 for other appropriate disposition of various statutes that were
14 omitted from enacted codes;

15 (2) conforming codifications enacted by the 81st
16 Legislature to other Acts of that legislature that amended the laws
17 codified or added new law to subject matter codified;

18 (3) making necessary corrections to enacted
19 codifications; and

20 (4) renumbering or otherwise redesignating titles,
21 chapters, and sections of codes that duplicate title, chapter, or
22 section designations.

23 SECTION 1.002. (a) The repeal of a statute by this Act does
24 not affect an amendment, revision, or reenactment of the statute by

1 the 82nd Legislature, Regular Session, 2011. The amendment,
2 revision, or reenactment is preserved and given effect as part of
3 the code provision that revised the statute so amended, revised, or
4 reenacted.

5 (b) If any provision of this Act conflicts with a statute
6 enacted by the 82nd Legislature, Regular Session, 2011, the statute
7 controls.

8 SECTION 1.003. (a) A transition or saving provision of a
9 law codified by this Act applies to the codified law to the same
10 extent as it applied to the original law.

11 (b) The repeal of a transition or saving provision by this
12 Act does not affect the application of the provision to the codified
13 law.

14 (c) In this section, "transition provision" includes any
15 temporary provision providing for a special situation in the
16 transition period between the existing law and the establishment or
17 implementation of the new law.

18 ARTICLE 2. CHANGES RELATING TO AGRICULTURE CODE

19 SECTION 2.001. Section 16.005(b), Agriculture Code, as
20 amended by Chapters 1295 (H.B. 2318) and 1312 (H.B. 2582), Acts of
21 the 81st Legislature, Regular Session, 2009, is reenacted to read
22 as follows:

23 (b) For each fiscal year, the office may not impose fees on a
24 producer for more than 18 million gallons of fuel ethanol,
25 biodiesel, or renewable diesel or MMBtu of renewable methane
26 produced at any one registered plant.

27 SECTION 2.002. Section 16.006(c), Agriculture Code, as

1 amended by Chapters 1295 (H.B. 2318) and 1312 (H.B. 2582), Acts of
2 the 81st Legislature, Regular Session, 2009, is reenacted to read
3 as follows:

4 (c) For each fiscal year a producer may not receive grants
5 for more than 18 million gallons of fuel ethanol, biodiesel, or
6 renewable diesel or MMBtu of renewable methane produced at any one
7 registered plant.

8 SECTION 2.003. The heading to Section 58.057, Agriculture
9 Code, is repealed to conform to the repeal of Sections 58.057(a),
10 (c), and (e), Agriculture Code, by Chapter 506 (S.B. 1016), Acts of
11 the 81st Legislature, Regular Session, 2009, and the transfer of
12 Sections 58.057(b) and (d), Agriculture Code, to Section 58.032,
13 Agriculture Code, by Chapter 506 (S.B. 1016), Acts of the 81st
14 Legislature, Regular Session, 2009.

15 SECTION 2.004. Section 203.052(c), Agriculture Code, as
16 amended by Chapters 200 (H.B. 3442) and 983 (S.B. 1828), Acts of the
17 78th Legislature, Regular Session, 2003, is reenacted to read as
18 follows:

19 (c) At the hearing, representatives of a district and any
20 other person may appear and present testimony including information
21 and suggestions for any changes in the proposed plan. The board
22 shall:

23 (1) enter any written comments received on the
24 proposed plan into the record of the hearing; and

25 (2) consider all written comments and testimony before
26 taking final action on the proposed plan.

27 SECTION 2.005. Section 302.002, Agriculture Code, is

1 amended to conform to Chapters 816 (S.B. 279) and 1245 (S.B. 1700),
2 Acts of the 78th Legislature, Regular Session, 2003, to read as
3 follows:

4 Sec. 302.002. DEFINITIONS [~~DEFINITION~~]. In this chapter:

5 (1) "Commission" means the Texas Commission of
6 Licensing and Regulation.

7 (2) "Department" means the Texas Department of
8 Licensing and Regulation.

9 (3) "Weather [~~,"weather~~] modification and control"
10 means changing or controlling, or attempting to change or control,
11 by artificial methods the natural development of atmospheric cloud
12 forms or precipitation forms that occur in the troposphere.

13 ARTICLE 3. CHANGES RELATING TO ALCOHOLIC BEVERAGE CODE

14 SECTION 3.001. Section 48.03, Alcoholic Beverage Code, is
15 amended to correct a reference to read as follows:

16 Sec. 48.03. ELIGIBILITY FOR PERMIT. The commission or
17 administrator may issue a passenger train beverage permit to any
18 corporation organized under the Business Organizations Code or
19 former Title 112, Revised Statutes, or under the Rail Passenger
20 Service Act of 1970, as amended (45 U.S.C.A. Section 501 et seq.),
21 operating a commercial passenger train service in or through the
22 state. Application and payment of the fee shall be made directly to
23 the commission.

24 ARTICLE 4. CHANGES RELATING TO BUSINESS & COMMERCE CODE

25 SECTION 4.001. Sections 35.60 and 35.63, Business &
26 Commerce Code, are repealed to conform to the repeal of Chapter 35,
27 Business & Commerce Code, by Chapter 885 (H.B. 2278), Acts of the

1 80th Legislature, Regular Session, 2007.

2 ARTICLE 5. CHANGES RELATING TO CIVIL PRACTICE AND REMEDIES CODE

3 SECTION 5.001. Section 64.072(d), Civil Practice and
4 Remedies Code, is amended to correct references to read as follows:

5 (d) A court may not extend a corporate receivership for more
6 than five years beyond the original three years, except that the
7 court may extend for any additional period the receivership of a
8 corporation organized [~~and existing~~] under former Article
9 3.05(A)(2), Texas Miscellaneous Corporation Laws Act (Article
10 1302-3.05, Vernon's Texas Civil Statutes), Section 2.006, Business
11 Organizations Code, before September 1, 2009, or a railroad
12 corporation organized under the Business Organizations Code or
13 former Title 112, Revised Statutes.

14 SECTION 5.002. Section 125.061(3), Civil Practice and
15 Remedies Code, is amended to correct a reference to read as follows:

16 (3) "Gang activity" means the following types of
17 conduct:

18 (A) organized criminal activity as described by
19 Section 71.02, Penal Code;

20 (B) terroristic threat as described by Section
21 22.07, Penal Code;

22 (C) coercing, soliciting, or inducing gang
23 membership as described by Section 71.022(a) or (a-1) [~~22.015~~],
24 Penal Code;

25 (D) criminal trespass as described by Section
26 30.05, Penal Code;

27 (E) disorderly conduct as described by Section

1 42.01, Penal Code;

2 (F) criminal mischief as described by Section
3 28.03, Penal Code, that causes a pecuniary loss of \$500 or more;

4 (G) a graffiti offense in violation of Section
5 28.08, Penal Code, that:

6 (i) causes a pecuniary loss of \$500 or more;

7 or

8 (ii) occurs at a school, an institution of
9 higher education, a place of worship or human cemetery, a public
10 monument, or a community center that provides medical, social, or
11 educational programs;

12 (H) a weapons offense in violation of Chapter 46,
13 Penal Code; or

14 (I) unlawful possession of a substance or other
15 item in violation of Chapter 481, Health and Safety Code.

16 ARTICLE 6. CHANGES RELATING TO CODE OF CRIMINAL PROCEDURE

17 SECTION 6.001. Article 2.27, Code of Criminal Procedure, as
18 amended by Chapters 867 (S.B. 669) and 1210 (S.B. 1074), Acts of the
19 78th Legislature, Regular Session, 2003, is reenacted and amended
20 to read as follows:

21 Art. 2.27. INVESTIGATION OF CERTAIN REPORTS ALLEGING ABUSE.

22 (a) On receipt of a report that is assigned the highest priority in
23 accordance with rules adopted by the Department of Family and
24 Protective [~~and Regulatory~~] Services under Section 261.301(d),
25 Family Code, and that alleges an immediate risk of physical or
26 sexual abuse of a child that could result in the death of or serious
27 harm to the child by a person responsible for the care, custody, or

1 welfare of the child, a peace officer from the appropriate local law
2 enforcement agency shall investigate the report jointly with the
3 department or with the agency responsible for conducting an
4 investigation under Subchapter E, Chapter 261, Family Code. As soon
5 as possible after being notified by the department of the report,
6 but not later than 24 hours after being notified, the peace officer
7 shall accompany the department investigator in initially
8 responding to the report.

9 (b) On receipt of a report of abuse or neglect or other
10 complaint of a resident of a nursing home, convalescent home, or
11 other related institution under Section 242.126(c)(1), Health and
12 Safety Code, the appropriate local law enforcement agency shall
13 investigate the report as required by Section 242.135, Health and
14 Safety Code.

15 SECTION 6.002. Section 1, Article 55.02, Code of Criminal
16 Procedure, is amended to correct a reference to read as follows:

17 Sec. 1. At the request of the defendant and after notice to
18 the state, the trial court presiding over the case in which the
19 defendant was acquitted, if the trial court is a district court, or
20 a district court in the county in which the trial court is located
21 shall enter an order of expunction for a person entitled to
22 expunction under Article 55.01(a)(1)(A) [~~article 55.01(a)(1)(a)~~]
23 not later than the 30th day after the date of the acquittal. Upon
24 acquittal, the trial court shall advise the defendant of the right
25 to expunction. The defendant shall provide to the district court
26 all of the information required in a petition for expunction under
27 Section 2(b). The attorney for the defendant in the case in which

1 the defendant was acquitted, if the defendant was represented by
2 counsel, or the attorney for the state, if the defendant was not
3 represented by counsel, shall prepare the order for the court's
4 signature.

5 SECTION 6.003. Article 59.01(2), Code of Criminal
6 Procedure, as amended by Chapters 153 (S.B. 2225), 1130 (H.B.
7 2086), and 1357 (S.B. 554), Acts of the 81st Legislature, Regular
8 Session, 2009, is reenacted and amended to read as follows:

9 (2) "Contraband" means property of any nature,
10 including real, personal, tangible, or intangible, that is:

11 (A) used in the commission of:

12 (i) any first or second degree felony under
13 the Penal Code;

14 (ii) any felony under Section 15.031(b),
15 20.05, 21.11, 38.04, Subchapter B of Chapter 43, or Chapter 29, 30,
16 31, 32, 33, 33A, or 35, Penal Code;

17 (iii) any felony under The Securities Act
18 (Article 581-1 et seq., Vernon's Texas Civil Statutes); or

19 (iv) any offense under Chapter 49, Penal
20 Code, that is punishable as a felony of the third degree or state
21 jail felony, if the defendant has been previously convicted three
22 times of an offense under that chapter;

23 (B) used or intended to be used in the commission
24 of:

25 (i) any felony under Chapter 481, Health
26 and Safety Code (Texas Controlled Substances Act);

27 (ii) any felony under Chapter 483, Health

1 and Safety Code;

2 (iii) a felony under Chapter 153, Finance
3 Code;

4 (iv) any felony under Chapter 34, Penal
5 Code;

6 (v) a Class A misdemeanor under Subchapter
7 B, Chapter 365, Health and Safety Code, if the defendant has been
8 previously convicted twice of an offense under that subchapter;

9 (vi) any felony under Chapter 152, Finance
10 Code;

11 (vii) any felony under Chapter 32, Human
12 Resources Code, or Chapter 31, 32, 35A, or 37, Penal Code, that
13 involves the state Medicaid program;

14 (viii) a Class B misdemeanor under Chapter
15 522, Business & Commerce Code;

16 (ix) a Class A misdemeanor under Section
17 306.051, Business & Commerce Code; ~~or~~

18 (x) any offense under Section 42.10, Penal
19 Code;

20 (xi) ~~[(x)]~~ any offense under Section
21 46.06(a)(1) or 46.14, Penal Code; or

22 (xii) ~~[(x)]~~ any offense under Chapter 71,
23 Penal Code;

24 (C) the proceeds gained from the commission of a
25 felony listed in Paragraph (A) or (B) of this subdivision, a
26 misdemeanor listed in Paragraph (B)(viii), (x), (xi), or (xii)
27 ~~[(B)(viii) or (x)]~~ of this subdivision, or a crime of violence;

1 (D) acquired with proceeds gained from the
2 commission of a felony listed in Paragraph (A) or (B) of this
3 subdivision, a misdemeanor listed in Paragraph (B)(viii), (x),
4 (xi), or (xii) [~~(B)(viii) or (x)~~] of this subdivision, or a crime of
5 violence; or

6 (E) used to facilitate or intended to be used to
7 facilitate the commission of a felony under Section 15.031 or
8 43.25, Penal Code.

9 SECTION 6.004. Article 59.011, Code of Criminal Procedure,
10 as added by Chapters 153 (S.B. 2225), 1130 (H.B. 2086), and 1357
11 (S.B. 554), Acts of the 81st Legislature, Regular Session, 2009, is
12 reenacted and amended to read as follows:

13 Art. 59.011. ELECTION OF FORFEITURE PROCEEDING. If
14 property described by Article 59.01(2)(B)(x), (xi), or (xii) is
15 subject to forfeiture under this chapter and Article 18.18, the
16 attorney representing the state may proceed under either this
17 chapter or that article.

18 SECTION 6.005. Article 62.051(c), Code of Criminal
19 Procedure, as amended by Chapters 661 (H.B. 2153) and 755 (S.B.
20 689), Acts of the 81st Legislature, Regular Session, 2009, is
21 reenacted and amended to read as follows:

22 (c) The registration form shall require:

23 (1) the person's full name, date of birth, sex, race,
24 height, weight, eye color, hair color, social security number,
25 driver's license number, and shoe size;

26 (1-a) [~~and~~] the address at which the person resides
27 or intends to reside or, if the person does not reside or intend to

1 reside at a physical address, a detailed description of each
2 geographical location at which the person resides or intends to
3 reside;

4 (1-b) [~~and~~] each alias used by the person and any home,
5 work, or cellular telephone number of the person;

6 (2) a recent color photograph or, if possible, an
7 electronic digital image of the person and a complete set of the
8 person's fingerprints;

9 (3) the type of offense the person was convicted of,
10 the age of the victim, the date of conviction, and the punishment
11 received;

12 (4) an indication as to whether the person is
13 discharged, paroled, or released on juvenile probation, community
14 supervision, or mandatory supervision;

15 (5) an indication of each license, as defined by
16 Article 62.005(g), that is held or sought by the person;

17 (6) an indication as to whether the person is or will
18 be employed, carrying on a vocation, or a student at a particular
19 public or private institution of higher education in this state or
20 another state, and the name and address of that institution;

21 (7) the identification of any online identifier
22 established or used by the person; and

23 (8) any other information required by the department.

24 SECTION 6.006. Article 102.0045(d), Code of Criminal
25 Procedure, is amended to correct a reference to read as follows:

26 (d) Fees deposited in the jury service fund under this
27 article [~~section~~] are exempt from the application of Section

1 403.095, Government Code.

2 SECTION 6.007. Article 102.0185(c), Code of Criminal
3 Procedure, is amended to correct a reference to read as follows:

4 (c) Costs imposed under this article are collected in the
5 ~~[same]~~ manner provided by Subchapter B, Chapter 133, Local
6 Government Code ~~[as other costs collected under Article 102.075]~~.

7 SECTION 6.008. Articles 102.056(c) and (d), Code of
8 Criminal Procedure, are amended to correct references to read as
9 follows:

10 (c) Notwithstanding any other provision of this article

12 unit of government or combination of local units of government
13 located in an impacted region occurring as the result of the

2 (3) a prohibition, restriction, or requirement, as
3 applicable, imposed by this title or a rule adopted under this
4 title, relating to:

5 (A) the Public Education Information Management
6 System (PEIMS) to the extent necessary to monitor compliance with
7 this subchapter as determined by the commissioner;

8 (B) educator certification under Chapter 21 and
9 educator rights under Sections 21.407, 21.408, and 22.001;

10 (C) criminal history records under Subchapter C,
11 Chapter 22;

12 (D) student admissions under Section 25.001;

13 (E) school attendance under Sections 25.085,
14 25.086, and 25.087;

15 (F) inter-district or inter-county transfers of
16 students under Subchapter B, Chapter 25;

17 (G) elementary class size limits under Section
18 25.112, in the case of any campus in the district that fails to
19 satisfy any standard under Section 39.054(e) [~~39.054(d)~~];

20 (H) high school graduation under Section 28.025;

21 (I) special education programs under Subchapter
22 A, Chapter 29;

23 (J) bilingual education under Subchapter B,
24 Chapter 29;

25 (K) prekindergarten programs under Subchapter E,
26 Chapter 29;

27 (L) safety provisions relating to the

1 transportation of students under Sections 34.002, 34.003, 34.004,
2 and 34.008;

3 (M) computation and distribution of state aid
4 under Chapters 31, 42, and 43;

5 (N) extracurricular activities under Section
6 33.081;

7 (O) health and safety under Chapter 38;

8 (P) public school accountability under
9 Subchapters B, C, D, E, and J, Chapter 39;

10 (Q) equalized wealth under Chapter 41;

11 (R) a bond or other obligation or tax rate under
12 Chapters 42, 43, and 45; and

13 (S) purchasing under Chapter 44.

14 SECTION 7.002. Section 12.119(c), Education Code, is
15 amended to correct a reference to read as follows:

16 (c) On request, the State Board of Education shall provide
17 the information required by this section and Section 12.111(a)(8)
18 [~~12.111(8)~~] to a member of the public. The board may charge a
19 reasonable fee to cover the board's cost in providing the
20 information.

21 SECTION 7.003. Section 21.4551(c), Education Code, is
22 amended to correct a reference to read as follows:

23 (c) The commissioner by rule shall require a teacher to
24 attend a reading academy if the teacher provides instruction in
25 reading, mathematics, science, or social studies to students at the
26 sixth, seventh, or eighth grade level at a campus that fails to
27 satisfy any standard under Section 39.054(e) [~~39.054(d)~~] on the

1 basis of student performance on the reading assessment instrument
2 administered under Section 39.023(a) to students in any grade level
3 at the campus.

4 SECTION 7.004. Section 21.705, Education Code, as amended
5 by Chapters 1262 (H.B. 709) and 1328 (H.B. 3646), Acts of the 81st
6 Legislature, Regular Session, 2009, is reenacted to read as
7 follows:

8 Sec. 21.705. AWARD PAYMENTS. A school district must use at
9 least 60 percent of grant funds awarded to the district under this
10 subchapter to directly award classroom teachers and principals who
11 effectively improve student achievement as determined by
12 meaningful, objective measures. The remaining funds must be used
13 only to:

14 (1) provide teacher induction and mentoring support,
15 including stipends to effective mentors or teacher coaches;

16 (2) provide stipends to classroom teachers who are
17 certified in a subject that is designated by the commissioner as
18 commonly experiencing a critical shortage of teachers;

19 (3) provide stipends to classroom teachers who are
20 certified under Subchapter B in the main subject area in which they
21 teach;

22 (4) provide stipends to recruit and retain classroom
23 teachers and principals with proven records of success for
24 improving student performance who are assigned to campuses at which
25 the district has experienced difficulty assigning or retaining
26 teachers;

27 (5) provide stipends to classroom teachers who hold

1 advanced certification from an organization that certifies at least
2 2,500 teachers in the United States each year based on the teachers'
3 satisfaction, through study, expert evaluation, self-assessment,
4 and peer review, of high and rigorous standards for accomplished
5 teaching;

6 (6) provide awards to other campus employees who
7 demonstrate excellence;

8 (7) implement the components of a Teacher Advancement
9 Program (TAP), including:

10 (A) an instructionally focused accountability
11 system; and

12 (B) the adjustment of teaching schedules to
13 permit ongoing applied professional growth; or

14 (8) provide funding for previously developed
15 incentive programs.

16 SECTION 7.005. Section 25.087(b), Education Code, as
17 amended by Chapters 517 (S.B. 1134) and 595 (H.B. 192), Acts of the
18 81st Legislature, Regular Session, 2009, is reenacted and amended
19 to read as follows:

20 (b) A school district shall excuse a student from attending
21 school for:

22 (1) the following purposes, including travel for those
23 purposes:

24 (A) observing religious holy days;

25 (B) attending a required court appearance;

26 (C) appearing at a governmental office to
27 complete paperwork required in connection with the student's

1 application for United States citizenship; ~~[or]~~

2 (D) taking part in a United States naturalization
3 oath ceremony; or

4 (E) ~~[(C)]~~ serving as an election clerk; or

5 (2) a temporary absence resulting from health care
6 professionals if that student commences classes or returns to
7 school on the same day of the appointment.

8 SECTION 7.006. Section 28.0211(k), Education Code, is
9 amended to correct a reference to read as follows:

10 (k) The commissioner shall adopt rules as necessary to
11 implement this section, including rules concerning when school
12 districts shall administer assessment instruments required under
13 this section and which administration of the assessment instruments
14 will be used for purposes of Section 39.054 ~~[39.051]~~.

15 SECTION 7.007. Section 29.202(a), Education Code, is
16 amended to correct a reference to read as follows:

17 (a) A student is eligible to receive a public education
18 grant or to attend another public school in the district in which
19 the student resides under this subchapter if the student is
20 assigned to attend a public school campus:

21 (1) at which 50 percent or more of the students did not
22 perform satisfactorily on an assessment instrument administered
23 under Section 39.023(a) or (c) in any two of the preceding three
24 years; or

25 (2) that, at any time in the preceding three years,
26 failed to satisfy any standard under Section 39.054(e) ~~[39.054(d)]~~.

27 SECTION 7.008. Section 30A.002(b), Education Code, as

1 amended by Chapters 850 (S.B. 2248) and 1328 (H.B. 3646), Acts of
2 the 81st Legislature, Regular Session, 2009, is reenacted and
3 amended to read as follows:

4 (b) A student is eligible to enroll full-time in courses
5 provided through the state virtual school network only if the
6 student:

7 (1) [~~the student~~] was enrolled in a public school in
8 this state in the preceding school year; or

9 (2) [~~(3) the student~~] has been placed in substitute
10 care in this state, regardless of whether the student was enrolled
11 in a public school in this state in the preceding school year.

12 SECTION 7.009. Section 32.261(b), Education Code, is
13 amended to correct a reference to read as follows:

14 (b) To the extent possible considering other statutory
15 requirements, the commissioner and agency shall encourage the use
16 of textbook funds and technology allotment funds under Section
17 32.005 [~~31.021(b)(2)~~] in a manner that facilitates the development
18 and use of the portal.

19 SECTION 7.010. The heading to Section 39.106, Education
20 Code, is amended to read as follows:

21 Sec. 39.106. CAMPUS INTERVENTION TEAM DUTIES.

22 SECTION 7.011. The heading to Section 39.113, Education
23 Code, is amended to read as follows:

24 Sec. 39.113. CAMPUS INTERVENTION TEAM MEMBERS.

25 SECTION 7.012. Section 41.124(c), Education Code, is
26 amended to correct a reference to read as follows:

27 (c) A school district that receives tuition for a student

1 from a school district with a wealth per student that exceeds the
2 equalized wealth level may not claim attendance for that student
3 for purposes of Chapters 42 and 46 and the technology allotment
4 under Section 32.005 [~~31.021(b)(2)~~].

5 SECTION 7.013. Section 45.261(d), Education Code, is
6 amended to correct a reference to read as follows:

7 (d) If a school district fails to comply with the

11 49, Code of Federal Regulations.

12 (b) A railroad company that transports hazardous materials
13 in or through this state shall file with the department a copy of
14 each hazardous materials incident report that the company files
15 with the United States Department of Transportation under 49 C.F.R.
16 Section 171.16. The copy must be filed not later than the 15th day
17 after the date the incident that forms the basis of the report is
18 discovered.

19 (c) Not later than April 1 of each year, a railroad company
20 that transports hazardous materials in or through the state shall
21 provide to the department:

22 (1) a map depicting the location of each railroad main
23 line and branch line that the company owns, leases, or operates in
24 the state;

25 (2) a map delineating the geographical limits of the
26 company operating divisions or districts and identifying the
27 principal operating officer for the company in each operating

1 division or district;

2 (3) a primary and secondary telephone number for the
3 company dispatcher responsible for train operations in each
4 operating division or district;

5 (4) a list of each type of hazardous material by hazard
6 class and the quantity of the material transported over each
7 railroad line owned, leased, or operated by the company during the
8 preceding year; and

9 (5) the name and address of the company employee in
10 charge of training persons to handle an incident related to
11 hazardous materials.

12 (d) For the purposes of Subsection (c)(4), "hazard class"
13 means any one of the following, as defined by 49 C.F.R. Part 173,
14 or, with respect to hazardous waste, listed as a substance subject
15 to 40 C.F.R. Part 262:

16 (1) radioactive material;

17 (2) explosives, Class A;

18 (3) explosives, Class B;

19 (4) poison A;

20 (5) poison B;

21 (6) flammable gas;

22 (7) nonflammable gas;

23 (8) flammable liquid;

24 (9) oxidizer;

25 (10) flammable solid;

26 (11) corrosive material;

27 (12) combustible liquid;

1 (13) etiologic agent;

2 (14) other regulated material (ORM); or

3 (15) hazardous waste.

4 (e) If a substance fits the definition of more than one
5 hazard class, the substance must be classified in accordance with
6 the sequence stated in 49 C.F.R. Section 173.2a.

7 (f) The department shall compile information submitted to
8 the department under this section for distribution to local
9 emergency management agencies located in jurisdictions containing
10 reported railroad operations.

11 (g) At least once each year the Texas Division of Emergency
12 Management shall distribute the information compiled by the
13 department to the appropriate officials for inclusion in local
14 emergency management plans established under Subchapter E, Chapter
15 418, Government Code.

16 CHAPTER 194. PROVISION OF UTILITIES BY CERTAIN RAILWAY

17 CORPORATIONS

6 extension held by a public service corporation engaged in the
7 supply and sale of electric light, power, or gas as provided by law.

8 (d) The authority granted under this section does not
9 expressly or impliedly repeal any antitrust law of this state.

10 Sec. 194.002. DISTRIBUTION OF GAS OR ELECTRICITY FOLLOWING
11 ABANDONMENT OF STREET RAILWAY. (a) This section applies only to a
12 private corporation that on April 26, 1937, was authorized by its
13 charter and the statutes of this state to operate street and
14 interurban railways and had the power to distribute and sell gas or
15 electricity to the public.

16 (b) During the unexpired period of its corporate charter, a
17 corporation that abandons or discontinues or has abandoned or
18 discontinued the operation of its railways or motor buses
19 substituted for the railways may continue to distribute and sell
20 electricity or gas as authorized by its corporate charter and
21 statutes in the same manner as if the abandonment or
22 discontinuation had not occurred.
