1 AN ACT relating to the election of directors of the Real-Edwards 2 3 Conservation and Reclamation District. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 11, Chapter 341, Acts of the 56th 5 6 Legislature, Regular Session, 1959, is amended to read as follows: 7 Sec. 11. (a) The government and control of the District shall be vested in a Board of Directors consisting of nine [(9)] 8 members. Directors serve staggered four-year terms expiring on 9 10 January 1 of odd-numbered years. The District shall hold an election on the uniform 11 (b) 12 election date in November of each even-numbered year to elect the 13 appropriate number of Directors [There shall be held in the 14 District on the first Tuesday after the first Monday in November in each even-numbered year an election within the District for the 15 selection of Directors to succeed those whose terms expire on said 16 date. Such election shall be held in such voting boxes as are 17 designated by the Board of Directors, and notice of such election 18 shall be given by the Secretary of the Board of Directors by posting 19 in three (3) public places within the District a copy of the order 20 of the Board of Directors directing the time and places of holding 21 22 the election. No person shall be selected a Director unless he be above the age of twenty-one (21) years and a resident within the 23 territorial limits of the District]. 24

2 SECTION 3. This Act takes effect immediately if it receives 3 a vote of two-thirds of all the members elected to each house, as 4 provided by Section 39, Article III, Texas Constitution. If this 5 Act does not receive the vote necessary for immediate effect, this 6 Act takes effect September 1, 2011.
