- (3) the full name and date of birth of the holder; 19

- 21 the license holder's residence address or, for a

- 1 SECTION 3. Section 522.030, Transportation Code, is amended
- 2 to read as follows:
- 3 Sec. 522.030. CONTENT OF LICENSE. A commercial driver's
- 4 license must:
- 5 (1) be marked "Commercial Driver License" or "CDL";
- 6 (2) be, to the extent practicable, tamper-proof; and
- 7 (3) include:
- 8 (A) the name and mailing address of the person to
- 9 whom it is issued;
- 10 (B) the person's color or grayscale photograph;
- 11 (C) a physical description of the person,
- 12 including sex, height, and eye color;
- 13 (D) the person's date of birth;
- 14 (E) a number or identifier the department
- 15 considers appropriate;
- 16 (F) the person's signature;
- 17 (G) each class of commercial motor vehicle that
- 18 the person is authorized to drive, with any endorsements or

- SECTION 4. The changes in law made by this Act apply only to

- 27 or renewed before the effective date of this Act is governed by the

- 1 law in effect when the license or certificate was issued, and the
- 2 former law is continued in effect for that purpose.
- 3 SECTION 5. To the extent of any conflict, this Act prevails
- 4 over another Act of the 82nd Legislature, Regular Session, 2011,
- 5 relating to nonsubstantive additions to and corrections in enacted
- 6 codes.
- 7 SECTION 6. This Act takes effect September 1, 2011.
