- 2 relating to contributions to the fund for veterans' assistance.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Subsection (a), Section 434.017, Government
- 5 Code, as amended by Chapters 840 (S.B. 1940) and 1385 (S.B. 1655),
- 6 Acts of the 81st Legislature, Regular Session, 2009, is reenacted
- 7 and amended to read as follows:
- 8 (a) The fund for veterans' assistance is a special fund in
- 9 the state treasury outside the general revenue fund. The fund is
- 10 composed of:
- 11 (1) money transferred to the fund at the direction of
- 12 the legislature;
- 13 (2) gifts and grants contributed to the fund;
- 14 (3) the earnings of the fund; [and]
- 15 (4) money transferred to the fund from proceeds of the
- 16 lottery game operated under Section 466.027 or transferred to the
- 17 fund under Section 466.408(b); and
- (5) $\left[\frac{(2)}{(2)}\right]$ money deposited to the credit of the fund
- 19 under Section 502.1746, Transportation Code.
- SECTION 2. Section 502.1746, Transportation Code, is
- 21 amended by amending Subsection (b) and adding Subsections (c), (d),
- 22 and (e) to read as follows:
- 23 (b) The county assessor-collector shall send any
- 24 contribution made under this section to the comptroller for deposit

- 1 in the state treasury to the credit of the fund for veterans'
- 2 assistance before the 31st day after the date the contribution is
- 3 made. A contribution made under this section may be used only for
- 4 the purposes of the fund for veterans' assistance.
- 5 <u>(c)</u> The department shall:
- 6 (1) include space on each motor vehicle registration
- 7 renewal notice, on the page that states the total fee for
- 8 registration renewal, that allows a person renewing a registration
- 9 to indicate the amount that the person is voluntarily contributing
- 10 to the fund for veterans' assistance;
- 11 (2) provide an opportunity to contribute to the fund
- 12 for veterans' assistance similar to the opportunity described by
- 13 Subsection (a) and in the manner described by Subdivision (1) in any
- 14 registration renewal system that succeeds the system in place on
- 15 September 1, 2011; and
- 16 (3) provide an opportunity for a person to contribute
- 17 to the fund for veterans' assistance during the registration
- 18 renewal process on the department's Internet website.
- 19 (d) If a person makes a contribution under this section and
- 20 does not pay the full amount of a registration fee, the county
- 21 assessor-collector may credit all or a portion of the contribution
- 22 <u>to the person's registration fee.</u>
- 23 <u>(e) The department shall consult with the Texas Veterans</u>
- 24 Commission in performing the department's duties under this
- 25 section.
- 26 SECTION 3. The change in law made by this Act to Section
- 27 502.1746, Transportation Code, applies only to a motor vehicle

- 1 registration renewal notice issued for a registration that expires
- 2 on or after January 1, 2012.
- 3 SECTION 4. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2011.
