5	SECTION 1. Chapter 51, Education Code, is amended by adding

8	Sec. 51.451. DEFINITIONS. In this subchapter:
9	(1) "Coordinating board" means the Texas Higher
10	Education Coordinating Board.
11	(2) "General academic teaching institution,"
12	"governing board," and "university system" have the meanings
13	assigned by Section 61.003.
14	Sec. 51.452. ACADEMIC HEALTH CENTER. An academic health
15	center is a program that integrates biomedical and clinical
16	research, patient care, and predoctoral and postdoctoral teaching
17	provided by multiple participating institutions, schools, and
18	programs.
19	Sec. 51.453. ESTABLISHMENT. The governing board of a
20	university system may establish an academic health center as a
21	program of institutions of higher education under the board's
22	control and direction if the system meets the criteria provided by
23	this subchapter, as determined by the coordinating board. The
24	center must include as participants:

10	Sec. 51.454. DEMONSTRATION OF NEED AND SUPPORT. (a) The
11	coordinating board shall approve the establishment of an academic
12	health center under Section 51.453 if the coordinating board finds
13	that the university system seeking to establish the center has
14	demonstrated:
15	(1) a need for the center based on applicable
16	statewide and regional factors, including:
17	(A) demographic factors such as:
18	(i) age, income, and health condition; and
19	(ii) rate of persons without health care
20	coverage; and
21	(B) present or predicted physician-to-population
22	ratios or physician shortages in identified specialties;
23	(2) the system's ability to provide a teaching
24	hospital and other facilities adequate to support the center's
25	research, education, and clinical activities, considering the
26	proximity and availability of existing complementary facilities

No. 1648 1 (3) the center's capacity to expend in the aggregate a minimum of \$50 million annually in federally sponsored or privately 2 sponsored research, as evidenced by the research contracts of 3 participating institutions, provided that the center will 4 5 participate in those contracts; 6 (4) community support from a combination of state and 7 local governments, charities, chambers of commerce, hospitals, and 8 medical societies, as evidenced by commitments of financial and other resources with an aggregate value of at least \$35 million; and 9 10 (5) a well-defined business plan that includes identified financial resources estimated to be sufficient for the 11 12 ongoing support of the center, including support for medical 13 residencies. 14 (b) Health condition information considered under 15 Subsection (a)(1)(A)(i) may include health condition information relating to rates of disabilities, infant mortality, obesity, or 16 17 diabetes or other chronic conditions. Sec. 51.455. EFFECT ON FORMULA FUNDING. For purposes of the 18 19 appropriation formulas recommended by the coordinating board under Section 61.059, a student of an academic health center established 20 under this subchapter is considered to be a student of a 21 health-related institution to the extent that formula funding of 22 health-related institutions applies to the discipline in which the 23 24 student is enrolled. SECTION 2. This Act takes effect immediately if it receives 25 26 a vote of two-thirds of all the members elected to each house, as
