2	relating to confidentiality of Class C misdemeanor records related

4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Amend Chapter 44, Code of Criminal Procedure, by
6	adding Article 44.2811 as follows:
7	Art. 44.2811. RECORDS RELATING TO CHILDREN CONVICTED OF
8	FINE-ONLY MISDEMEANORS. All records and files and information
9	stored by electronic means or otherwise, from which a record or file
10	could be generated, relating to a child who is convicted of and has
11	satisfied the judgment for a fine-only misdemeanor offense other
12	than a traffic offense are confidential and may not be disclosed to
13	the public except as provided under Article 45.0217(b). All
14	records and files and information stored by electronic means or
15	otherwise, from which a record or file could be generated, relating
16	to a child whose conviction for a fine-only misdemeanor other than a
17	traffic offense is affirmed are confidential upon satisfaction of
18	the judgment and may not be disclosed to the public except as
19	<pre>provided under Article 45.0217(b).</pre>
20	SECTION 2. Amend Chapter 45, Code of Criminal Procedure, by
21	adding Article 45.0217 as follows:
22	Art. 45.0217. CONFIDENTIAL RECORDS RELATED TO THE
23	CONVICTION OF A CHILD. (a) Except as provided by Article 15.27,
24	Code of Criminal Procedure, and Subsection (b) of this section, all

- 1 records and files, including those held by law enforcement, and
- 2 information stored by electronic means or otherwise, from which a
- 3 record file could be generated, relating to a child who is convicted
- 4 of and has satisfied the judgment for a fine-only misdemeanor
- 5 offense other than a traffic offense are confidential and may not be
- 6 disclosed to the public.
- 7 (b) Information subject to Subsection (a) may be open to
- 8 <u>inspection only by:</u>
- 9 (1) judges or court staff;
- 10 (2) a criminal justice agency for a criminal justice
- 11 purpose, as those terms are defined by Section 411.082, Government
- 12 Code;
- 13 (3) the Department of Public Safety;
- 14 (4) an attorney for a party to the proceeding;
- 15 (5) the child defendant; or
- 16 (6) the defendant's parent, guardian, or managing
- 17 conservator.
- 18 SECTION 3. Repeal subsections (f-1) and (j) Government Code
- 19 Sec. 411.081.
- 20 SECTION 4. Amend Government Code Sec. 411.0851 as follows:
- 21 411.0851. DUTY OF PRIVATE ENTITY TO UPDATE CRIMINAL HISTORY RECORD
- 22 INFORMATION; CIVIL LIABILITY. (a) A private entity that compiles
- 23 and disseminates for compensation criminal history record
- 24 information shall destroy and may not disseminate any information
- 25 in the possession of the entity with respect to which the entity has
- 26 received notice that:
- 27 (1) an order of expunction has been issued under

- 1 Article 55.02, Code of Criminal Procedure; or
- 2 (2) an order of nondisclosure has been issued under
- 3 Section 411.081(d) or (f-1).
- 4 SECTION 5. Amend Government Code Sec. 552.142 as follows:
- 5 Sec. 552.142. EXCEPTION: RECORDS OF CERTAIN DEFERRED
- 6 ADJUDICATIONS AND CERTAIN MISDEMEANORS PUNISHABLE BY FINE ONLY.
- 7 (a) Information is excepted from the requirements of Section
- 8 552.021 if an order of nondisclosure with respect to the
- 9 information has been issued under Section 411.081(d) or (f-1).
- 10 SECTION 6. Amend Government Code Sec. 552.1425 as follows:
- 11 Sec. 552.1425. CIVIL PENALTY: DISSEMINATION OF CERTAIN
- 12 CRIMINAL HISTORY INFORMATION. (a) A private entity that compiles
- 13 and disseminates for compensation criminal history record
- 14 information may not compile or disseminate information with respect
- 15 to which the entity has received notice that:
- 16 (1) an order of expunction has been issued under
- 17 Article 55.02, Code of Criminal Procedure; or
- 18 (2) an order of nondisclosure has been issued under
- 19 Section 411.081(d) or (f-1).
- SECTION 7. Amend Chapter 58, Family Code, by adding Section
- 21 58.00711 as follows:
- 22 <u>Sec. 58.00711. RECORDS RELATING TO CHILDREN CONVICTED OF</u>
- 23 FINE-ONLY MISDEMEANORS. Except as provided by Article 45.0217(b),
- 24 Code of Criminal Procedure, all records and files and information
- 25 stored by electronic means or otherwise, from which a record or file
- 26 <u>could be generated</u>, relating to a child who is convicted of and has
- 27 satisfied the judgment for a fine-only misdemeanor offense other

- 1 than a traffic offense are confidential and may not be disclosed to
- 2 the public.
- 3 SECTION 8. The changes in law made by this Act apply to
- 4 convictions before, on, or after the effective date of this Act.
- 5 SECTION 9. This Act takes effect September 1, 2011.
