A BILL TO BE ENTITLED

1 AN ACT
2 relating to the composition of the districts for the election of
3 members of the Texas Senate.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 ARTICLE I

6 SECTION 1. (a) The members of the Texas Senate are elected
7 from the districts described by Article II of this Act.

8 (b) One member is elected from each district established by
9 this Act.

10 (c) The districts established by this Act are identified as
11 PLANS100 on the redistricting computer system operated by the Texas
12 Legislative Council.

13 ARTICLE II

10 SECTION 31. District 31 is composed of Andrews, Bailey,
11 Cochran, Crane, Dallam, Deaf Smith, Ector, Gaines, Glasscock,
12 Hansford, Hartley, Hemphill, Howard, Hutchinson, Lipscomb, Martin,
13 Midland, Moore, Ochiltree, Oldham, Parmer, Potter, Randall,
14 Roberts, Sherman and Yoakum Counties.

15 ARTICLE III

16 SECTION 1. In this Act, "tract," "block group," and "block"
17 mean the geographic areas identified by those terms on the 2000
18 Census TIGER/Line File, prepared by the federal Bureau of the
19 Census for the Twenty-second Decennial Census of the United States,
20 enumerated as of April 1, 2000.

21 SECTION 2. It is the intention of the Texas Legislature
22 that, if any county, tract, block group, block, or other geographic
23 area has erroneously been left out of this Act, a court reviewing
24 this Act should include that area in the appropriate district in
25 accordance with the intent of the legislature, using any available
26 evidence of that intent, including evidence such as that used by the
27 Supreme Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W.

1 749 (1922).

2 SECTION 3. This Act supersedes all previous enactments or
3 orders adopting districts for the Texas Senate. All previous acts
4 of the legislature adopting districts for the Texas Senate are
5 repealed.

6 SECTION 4. The districts set out in Article II of this Act
7 apply to the election of the members of the Texas Senate beginning
8 with the primary and general elections in 2012 for members of the
9 83rd Legislature. This Act does not affect the membership or
10 districts of the Senate of the 82nd Texas Legislature.

11 SECTION 5. This Act takes effect immediately if it receives
12 a vote of two-thirds of all the members elected to each house, as
13 provided by Section 39, Article III, Texas Constitution. If this
14 Act does not receive the vote necessary for immediate effect, this
15 Act takes effect on the 91st day after the last day of the
16 legislative session.
