4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 85, Health and Safety Code, is amended by
6	adding Subchapter K to read as follows:
7	SUBCHAPTER K. TEXAS HIV MEDICATION ADVISORY COMMITTEE
8	Sec. 85.271. DEFINITIONS. In this subchapter:
9	(1) "Commissioner" means the commissioner of the
10	department.
11	(2) "Committee" means the Texas HIV Medication
12	Advisory Committee.
13	(3) "Executive commissioner" means the executive
14	commissioner of the Health and Human Services Commission.
15	(4) "Program" means the Texas HIV medication program

- 17 Sec. 85.272. TEXAS HIV MEDICATION ADVISORY COMMITTEE. (a)
- The executive commissioner shall establish the committee. 18
- 19 (b) The committee consists of 11 members appointed by the
- executive commissioner. The committee must include: 20
- 21 (1) three physicians who are actively engaged in the
- treatment of adults who are infected with HIV; 22
- 23 (2) one physician who is actively engaged in the
- 24 treatment of infants and children who are infected with HIV;

1 (3) four consumers who are diagnosed with HIV; 2 (4) one person who is an administrator for a public, nonprofit hospital that provides services to individuals who are 3 4 infected with HIV; 5 (5) one social worker who works with individuals who are infected with HIV; and 6 7 (6) one pharmacist who participates in the program. 8 The department shall provide staff support for the committee. 9 10 (d) Except as provided by this subchapter, the committee is subject to Chapter 2110, Government Code. 11 12 Sec. 85.273. DUTIES. (a) The committee shall advise the executive commissioner and the department in the development of 13 14 procedures and guidelines for the program. 15 (b) The committee shall: 16 (1) review the program's goals and aims; 17 (2) evaluate the program's ongoing efforts; (3) recommend both short-range and long-range goals 18 19 and objectives for medication needs; and (4) perform any other tasks assigned by the executive 20 21 commissioner. Sec. 85.274. TERMS. A committee member serves at the will 22 of the executive commissioner. 23

- 3 (c) An officer may continue to serve until a replacement is
- 4 <u>elected for the officer's position.</u>
- 5 (d) The presiding officer shall:
- 6 (1) preside at all committee meetings attended by the
- 7 presiding officer;
- 8 (2) call meetings in accordance with this subchapter;
- 9 (3) appoint subcommittees as necessary; and
- 10 (4) ensure annual reports are made to the
- 11 commissioner.
- 12 (e) The presiding officer may serve as an ex officio member
- 13 of any subcommittee.
- 14 (f) The assistant presiding officer shall:
- 15 (1) perform the duties of the presiding officer if the
- 16 presiding officer is absent or becomes disabled; and
- 17 (2) complete the unexpired portion of the presiding
- 18 officer's term if the office of the presiding officer becomes
- 19 vacant.
- 20 (g) The committee may elect a committee member to replace
- 21 the assistant presiding officer if the office of the assistant
- 22 presiding officer becomes vacant.
- Sec. 85.276. MEETINGS. (a) The committee shall meet only
- 24 as necessary to conduct committee business.
- 25 (b) A meeting may be called by agreement between the
- 26 department staff and:
- 27 (1) the presiding officer; or

Τ	(2) three or more members of the committee.
2	(c) The department staff shall:
3	(1) make meeting arrangements; and
4	(2) contact each committee member to determine the
5	member's availability for a meeting date and place.
6	(d) The committee is not a "governmental body" as defined by
7	Chapter 551, Government Code. However, each committee meeting must
8	be announced and conducted in accordance with Chapter 551,
9	Government Code, except that the provisions allowing executive
10	sessions do not apply to the committee.
11	(e) Each member of the committee must be informed of a
12	committee meeting at least five working days before the meeting is
13	to take place.
14	(f) An agenda for each committee meeting must include an
15	item entitled "public comment" under which any person may address
16	the committee on matters relating to committee business. The
17	presiding officer may establish procedures for public comment,
18	including a time limit for each comment.
19	Sec. 85.277. ATTENDANCE. (a) A member shall attend:
20	(1) a scheduled committee meeting; and
21	(2) a meeting of a subcommittee to which the member is
22	assigned.
23	(b) A member shall notify the presiding officer or the
24	appropriate department staff if the member is unable to attend a
25	scheduled meeting.
26	(c) The committee shall include the attendance records of
27	each member in the committee's annual report to the commissioner.

- 1 The report must include a member's attendance at both committee and
- 2 subcommittee meetings.
- 3 Sec. 85.278. PROCEDURES. (a) The committee shall use
- 4 Robert's Rules of Order as the basis of parliamentary decisions
- 5 except as provided by other law or rule.
- 6 (b) An action taken by the committee must be approved by a
- 7 majority vote of the members present after a quorum is established.
- 8 <u>(c) Each member shall have one vote.</u>
- 9 (d) A member may not authorize another individual to
- 10 represent the member by proxy.
- 11 (e) The committee shall make decisions in the discharge of
- 12 the committee's duties without discrimination based on a person's
- 13 race, creed, gender, religion, national origin, age, physical
- 14 condition, or economic status.
- 15 (f) The department staff shall take minutes of each
- 16 committee meeting. After the minutes are approved by the
- 17 committee, the presiding officer shall sign the minutes.
- 18 Sec. 85.279. SUBCOMMITTEES. (a) The committee may
- 19 establish subcommittees as necessary to assist the committee in
- 20 performing the committee's duties.
- 21 (b) The presiding officer shall appoint committee members
- 22 to serve on subcommittees and to act as subcommittee chairs. The
- 23 presiding officer may appoint a person who is not a committee member
- 24 to serve on a subcommittee.
- 25 (c) A subcommittee shall meet when called by the
- 26 subcommittee's chair or when directed by the committee.
- 27 (d) A <u>subcommittee</u> chair shall make a regular report to the

- 1 committee at each committee meeting or in an interim written report
- 2 as needed. The report must include an executive summary or minutes
- 3 of each subcommittee meeting.
- 4 Sec. 85.280. STATEMENT BY MEMBER; MEMBER DUTIES. (a) The
- 5 executive commissioner, the department, and the committee may not
- 6 be bound by any statement made or action taken by a committee member
- 7 unless the member makes the statement or takes the action based on
- 8 specific instructions from the executive commissioner, the
- 9 department, or the committee.
- 10 (b) The committee and committee members may not participate
- 11 in any legislative activity in the name of the executive
- 12 commissioner, the department, or the committee unless the committee
- 13 or committee member obtains approval through the department's
- 14 <u>legislative process.</u> Committee members may represent themselves or
- 15 another entity in the legislative process.
- 16 (c) A committee member may not accept or solicit a benefit
- 17 that might reasonably tend to influence the member in the discharge
- 18 of the member's official duties.
- 19 (d) A committee member may not disclose confidential
- 20 information acquired through the member's service on the committee.
- 21 (e) A committee member may not knowingly solicit, accept, or
- 22 agree to accept a benefit for exercising the member's official
- 23 powers or duties in favor of another person.
- 24 (f) A committee member who has a personal or private
- 25 interest in a matter pending before the committee shall publicly
- 26 disclose the fact and may not vote or otherwise participate in the
- 27 matter.

- 1 (g) In this section, "personal or private interest" means a
- 2 direct pecuniary interest in a matter but does not include a
- 3 person's engagement in a profession, trade, or occupation if the
- 4 person's interest is the same as any other person who is similarly
- 5 engaged in the profession, trade, or occupation.
- 6 Sec. 85.281. COMPENSATION; EXPENSES. (a) A committee
- 7 member may receive reimbursement for expenses incurred for each day
- 8 the member engages in official committee business if the
- 9 reimbursement is authorized by the General Appropriations Act or
- 10 through the budget execution process.
- 11 (b) A committee member is not entitled to a salary or
- 12 stipend unless required by law.
- 13 (c) A committee member who is an employee of a state agency,
- 14 other than the department, is not entitled to reimbursement for
- 15 <u>expenses from the department.</u>
- 16 <u>(d) A person who serves on a subcommittee and who is not a</u>
- 17 committee member is not entitled to reimbursement for expenses from
- 18 the department.
- 19 (e) Only a consumer who is diagnosed with HIV and serves as a
- 20 committee member is eligible for reimbursement of actual travel
- 21 expenses incurred.
- 22 (f) A committee member who is eligible for reimbursement of
- 23 expenses shall submit to the department staff the member's receipts
- 24 for the expenses and any required forms not later than 14 days after
- 25 a committee meeting.
- 26 (g) A member shall make a request for reimbursement of
- 27 expenses on an official state travel voucher prepared by the

- 2 Sec. 85.282. REPORTS. (a) The committee shall file an
- 3 annual written report with the commissioner not later than March 31
- 4 of each year. The report must cover the meetings and activities of
- 5 the committee for the year preceding the date of the report.
- 6 (b) The report must include:
- 7 (1) the meeting dates of the committee and any
- 8 subcommittee;
- 9 (2) attendance records for each committee member;
- 10 (3) a brief description of any action taken by the
- 11 committee;
- 12 (4) a description of how the committee has
- 13 accomplished any specific tasks officially given to the committee;
- 14 (5) the status of any rules recommended by the
- 15 committee; and
- 16 (6) the anticipated activities of the committee for
- 17 the following year.
- 18 (c) The committee shall identify the costs for the
- 19 committee's existence in the report, including the cost of
- 20 department staff used to support the committee's activities and the
- 21 source of funds used to support the committee's activities.
- 22 <u>(d) The presiding officer and appropriate department staff</u>
- 23 shall sign the report.
- SECTION 2. Section 85.066, Health and Safety Code, is
- 25 repealed.
- 26 SECTION 3. (a) The executive commissioner of the Health and
- 27 Human Services Commission shall appoint the initial members of the

- 1 Texas HIV Medication Advisory Committee as provided by Section
- 2 85.272, Health and Safety Code, as added by this Act, as promptly as
- 3 possible after the effective date of this Act. The executive
- 4 commissioner may appoint, but is not required to appoint, initial
- 5 members to the committee who served on the advisory committee
- 6 previously established under Section 85.066, Health and Safety
- 7 Code, as repealed by this Act.
- 8 (b) The members of the Texas HIV Medication Advisory
- 9 Committee shall, at the first meeting of the committee, select a
- 10 presiding officer and an assistant presiding officer, and
- 11 notwithstanding Section 85.275(b), Health and Safety Code, as added
- 12 by this Act, the initial terms of those officers begin on the date
- 13 of selection.
- 14 SECTION 4. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2011.
