A BILL TO BE ENTITLED

- 2 relating to authorizing certain brewers and manufacturers to
- 3 conduct tours of their premises after which beer or ale is provided
- 4 to ultimate consumers for off-premises consumption.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Chapter 12, Alcoholic Beverage Code, is amended
- 7 by adding Section 12.07 to read as follows:
- 8 Sec. 12.07. TOUR OF PERMITTED PREMISES. (a) The holder of
- 9 a brewer's permit may give tours of the brewery premises and may
- 10 charge an admission fee for the tour.
- 11 (b) The holder of a brewer's permit whose annual production
- 12 of ale in this state does not exceed, together with the annual
- 13 production of beer by the holder of a manufacturer's license under
- 14 Section 62.15 at the same premises, a total of 250,000 barrels may,
- 15 at the end of a tour of the brewery premises, give ale to tour
- 16 participants in unbroken packages for off-premises consumption
- 17 without an additional charge.
- 18 <u>(c) The total amount of ale a tour participant may receive</u>
- 19 <u>in a single day under this section, together with the amount of beer</u>
- 20 the tour participant receives under Section 62.15 at the same
- 21 premises, may not exceed 48 12-ounce bottles.
- 22 (d) This section does not authorize the holder of a brewer's
- 23 permit to sell ale to an ultimate consumer.
- 24 SECTION 2. Chapter 62, Alcoholic Beverage Code, is amended

- 1 by adding Section 62.15 to read as follows:
- Sec. 62.15. TOUR OF LICENSED PREMISES. (a) The holder of a
- 3 manufacturer's license may give tours of the manufacturer's
- 4 premises and may charge an admission fee for the tour.
- 5 (b) The holder of a manufacturer's license whose annual
- 6 production of beer in this state does not exceed, together with the
- 7 annual production of ale by the holder of a brewer's permit under
- 8 Section 12.07 at the same premises, a total of 250,000 barrels may,
- 9 at the end of a tour of the manufacturer's premises, give beer to
- 10 tour participants in unbroken packages for off-premises
- 11 consumption without an additional charge.
- 12 (c) The total amount of beer a tour participant may receive
- 13 in a single day under this section, together with the amount of ale
- 14 the tour participant receives under Section 12.07 at the same
- 15 premises, may not exceed 48 12-ounce bottles.
- 16 <u>(d) This section does not authorize the holder of a</u>
- 17 manufacturer's license to sell beer to an ultimate consumer.
- SECTION 3. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2011.
