1-10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-11 SECTION 1. Section 46.002, Government Code, is amended to
1-12 read as follows:

1-13 Sec. 46.002. PROSECUTORS SUBJECT TO CHAPTER. This chapter
1-14 applies to the state prosecuting attorney, all county prosecutors,
1-15 and the following state prosecutors:
