## A JOINT RESOLUTION

- 1 proposing a constitutional amendment authorizing the legislature
- 2 to provide for an exemption from ad valorem taxation of the
- 3 residence homestead of the surviving spouse of a 100 percent or
- 4 totally disabled veteran in an amount equal to the amount of the
- 5 residence homestead exemption to which the disabled veteran was
- 6 entitled.
- 7 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 8 SECTION 1. Section 1-b, Article VIII, Texas Constitution,
- 9 is amended by adding Subsection (j) to read as follows:
- 10 <u>(j) The legislature by general law may provide that the</u>
- 11 surviving spouse of a 100 percent or totally disabled veteran who
- 12 qualified for an exemption in accordance with Subsection (i) of
- 13 this section when the disabled veteran died is entitled to an
- 14 exemption for the residence homestead of the surviving spouse in an
- 15 amount equal to the amount of the exemption received by the disabled
- 16 veteran on the residence homestead of the disabled veteran if the
- 17 surviving spouse has not remarried since the death of the disabled
- 18 <u>veteran.</u>
- 19 SECTION 2. The following temporary provision is added to
- 20 the Texas Constitution:
- 21 TEMPORARY PROVISION. (a) This temporary provision applies
- 22 to the constitutional amendment proposed by the 82nd Legislature,
- 23 Regular Session, 2011, authorizing the legislature to provide for
- 24 an exemption from ad valorem taxation of the residence homestead of

- 1 the surviving spouse of a 100 percent or totally disabled veteran in
- 2 an amount equal to the amount of the residence homestead exemption
- 3 to which the disabled veteran was entitled.
- 4 (b) Section 1-b(j), Article VIII, of this constitution
- 5 takes effect January 1, 2012, and applies only to a tax year
- 6 beginning on or after that date.
- 7 (c) This temporary provision expires January 1, 2013.
- 8 SECTION 3. This proposed constitutional amendment shall be
- 9 submitted to the voters at an election to be held November 8, 2011.
- 10 The ballot shall be printed to permit voting for or against the
- 11 proposition: "The constitutional amendment authorizing the
- 12 legislature to provide for an exemption from ad valorem taxation of
- 13 the residence homestead of the surviving spouse of a 100 percent or
- 14 totally disabled veteran in an amount equal to the amount of the
- 15 residence homestead exemption to which the disabled veteran was
- 16 entitled."
