Relating to honorary license plates for certain disabled veterans.

Relating to the taxation of certain tangible personal property located inside a defense base development authority.

Relating to certain state attorneys called into active duty military service.

Relating to deferral of certain surcharge payments for active duty military personnel.

Relating to privileged parking for recipients of the Silver Star Medal specialty license plate.

Relating to the free admission to state parks for the parents of deceased members of the armed services
