HB 170 Raymond | et al.  
Relating to bullying as a ground for removing a public school student from class and placing the student in a disciplinary alternative education program.

HB 485 Dutton  
Relating to public school disciplinary procedures and the evaluation of disciplinary alternative education programs.

HB 562 Berman  
Relating to the development of juvenile justice alternative education programs in counties with a population greater than 125,000.

HB 622 Hochberg  
Relating to disciplinary action taken against certain public school students on the basis of serious and persistent misbehavior.

HB 862 Patrick, Diane  
Relating to placing the State Board of Education and the State Board for Educator Certification under periodic review by the Sunset Advisory Commission.

HB 968 Strama  
Relating to expulsion from school or placement in a disciplinary alternative education program for certain conduct.

HB 1016 Castro  
Relating to a requirement that public school counselors demonstrate knowledge of counseling regarding higher education to obtain a school counselor certificate.

Relating to distinct certificate classes for public elementary school counselors and public secondary school counselors.

Relating to bullying, including cyberbullying, in public schools.

HB 1158 Eissler  
Relating to additional optional training and course work for public school principals.

HB 1160 Eissler  
Relating to certification to teach public school students who have visual impairments.

HB 1224 Reynolds  
Relating to expulsion of a public school student who commits certain criminal acts involving a computer, computer network, or computer system owned by or operated on behalf of a school district.

HB 1550 Aycock  
Relating to participation in state travel service contracts by open-enrollment charter schools.

HB 1587 Eissler  
Relating to the evaluation of public school teachers.

HB 1942 Patrick, Diane  
Relating to bullying in public schools.

HB 2158 Coleman  
Relating to a prohibition against the use of a stun gun or taser by school district peace officers, security personnel, and other employees against certain public school students.

HB 2349 Larson  
Relating to the authority of independent school districts to invest in corporate bonds.

HB 2378 Gonzales, Larry  
Relating to authorization for the appraisal of certain public school administrators by educators supervised by the administrators.

HB 2678 Smith, Todd  
Relating to the regulation of driver training schools and instruction.

HB 3018 Gutierrez  
Relating to a policy of a school district concerning possession of a paging device by a student.
