- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 21.355, Education Code, is amended to
- 6 read as follows:
- 7 Sec. 21.355. CONFIDENTIALITY. A document evaluating the
- 8 performance of a teacher or administrator, including a teacher or
- 9 administrator employed by an open-enrollment charter school, is
- 10 confidential.
- 11 SECTION 2. Section 21.355, Education Code, as amended by
- 12 this Act, applies to each document described by that section,
- 13 regardless of whether the document was created before, on, or after
- 14 the effective date of this Act.
- SECTION 3. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
- 17 provided by Section 39, Article III, Texas Constitution. If this
- 18 Act does not receive the vote necessary for immediate effect, this
- 19 Act takes effect September 1, 2011.
