- 1 WHEREAS, The year 2014 marks the 24th anniversary of the
- 2 death of Stevie Ray Vaughan, and this milestone provides a fitting
- 3 opportunity to reflect on the life and music of this Texas guitar
- 4 legend; and
- 5 WHEREAS, In the early morning hours of August 27, 1990, Mr.
- 6 Vaughan, then just 35 years of age, was killed in a helicopter crash
- 7 following a concert in Wisconsin; while his tragic death robbed the
- 8 world of a tremendous talent, it could not diminish the many
- 9 achievements this gifted musician realized during his short but
- 10 brilliant career; and
- 11 WHEREAS, The pride of Oak Cliff, Stevie Ray was born in that
- 12 Dallas community in 1954 and began playing in area bands while still
- 13 a student in junior high school; at age 17, he headed for Austin,
- 14 developing his explosive, blues-based style in the city's music
- 15 clubs; his years of hard work began to pay off after he began
- 16 performing with his legendary backup group, Double Trouble, in the
- 17 early 1980s; he got his first widespread exposure when he played
- 18 guitar on the David Bowie album Let's Dance, and he released his own
- 19 debut, Texas Flood, in 1983 to rave reviews; and
- 20 WHEREAS, Over the next seven years, Stevie Ray Vaughan
- 21 claimed his spot as one of the most influential rock and blues
- 22 guitarists of all time, with his smoldering fret work inspiring
- 23 everyone from music superstars to kids trying to learn their first
- 24 chords; all five albums he released during his lifetime became

- 1 million sellers, and his artistry was recognized with five Grammy
- 2 Awards, two of which were bestowed after his death; he also received
- 3 numerous other honors, and he and Double Trouble sold out concert
- 4 halls around the globe; and
- 5 WHEREAS, In addition to his professional success, this
- 6 revered musician was able to overcome his addiction to drugs and
- 7 alcohol in the mid-1980s, and in the years that followed, he lent a
- 8 helping hand to other musicians who struggled with substance abuse;
- 9 and
- 10 WHEREAS, Stevie Ray Vaughan's popularity has endured in the
- 11 decades since his passing, with younger generations embracing his
- 12 masterful guitar playing and heartfelt singing; fiery, evocative,
- 13 and full of Texas soul, his music has earned a special place in the
- 14 annals of American popular culture and is a source of pride and joy
- 15 for countless residents of the Lone Star State; now, therefore, be
- 16 it
- 17 RESOLVED, That the House of Representatives of the 83rd Texas
- 18 Legislature, 1st Called Session, hereby pay tribute to the legacy
- 19 of Stevie Ray Vaughan on the 24th anniversary of his death and honor
- 20 his contributions to our state's rich musical heritage.
