- WHEREAS, A loving daughter, sister, and granddaughter, Anne
- 20 Sullivan was adored by her family for her passion, her fierce
- 21 loyalty, and her tenacity, and she was respected by her fellow
- 22 firefighters for her courage and her commitment to the job; she
- 23 enriched the lives of all who shared in her journey, and those who
- 24 treasured this extraordinary young woman will forever hold her
