## RESOLUTION

- 1 WHEREAS, Distinguished activist Father Jose Alejandro
- 2 Solalinde Guerra has inspired countless people through his
- 3 humanitarian endeavors; and
- WHEREAS, Since April 2013, Father Solalinde has been
- 5 traveling across the United States with a caravan of victims turned
- 6 advocates to raise awareness of the plight of Central American
- 7 migrants; the caravan is called "Opening Doors to Hope," and
- 8 members of the group recount their experiences as migrants, discuss
- 9 such issues as the historical roots of migration, and educate the
- 10 public about human rights violations and criminals who prey on
- 11 those in transit; and
- 12 WHEREAS, Father Solalinde was born in the State of Mexico in
- 13 1945 and joined the Knights of Columbus in his youth; after
- 14 finishing his secondary education under the auspices of the Society
- 15 of Jesus, he studied classical literature at the High School
- 16 Institute of the Carmelite Fathers of Guadalajara before attending
- 17 the Institute of Ecclesiastical Studies, where he studied
- 18 philosophy and theology; he was ultimately ordained by the bishop
- 19 of Toluca; Father Solalinde holds a bachelor's degree in history
- 20 from the Autonomous University of the State of Mexico, as well as a
- 21 bachelor's degree in psychology and a master's degree in systemic
- 22 family therapy; and
- WHEREAS, After beginning his career in the Diocese of Toluca,
- 24 Father Solalinde requested a transfer to the poorest part of

- 1 Oaxaca, where he assisted the indigenous Mixtec people;
- 2 subsequently transferred to the Diocese of Tehuantepec, he led
- 3 several churches, offered family therapy, and established a shelter
- 4 for the orphaned, abandoned, and abused; while working in the
- 5 diocese, he learned about the kidnappings and other dangers faced
- 6 by migrants passing through on freight trains, and in 2007, he
- 7 founded a refuge, Hermanos del Camino, or "Brothers of the Road";
- 8 the haven has served thousands, and despite death threats from
- 9 criminal organizations, he has continued to work tirelessly to ease
- 10 the suffering of the most vulnerable and to champion their cause;
- 11 and
- 12 WHEREAS, This admired leader was presented with the 2012
- 13 National Human Rights Award by the chair of the National Human
- 14 Rights Commission and by the president of Mexico, Enrique Pena
- 15 Nieto; his numerous accolades also include the 2011 Emilio Krieger
- 16 Medal, the Peace and Democracy award from the National Association
- 17 of Democratic Lawyers, and the Pages Llergo Award for Democracy and
- 18 Human Rights; and
- 19 WHEREAS, Father Solalinde has made a positive difference in
- 20 the lives of innumerable people through his selfless devotion to
- 21 the disenfranchised, and his courageous efforts have focused
- 22 international attention on the human cost of immigration policies;
- 23 now, therefore, be it
- 24 RESOLVED, That the House of Representatives of the 83rd Texas
- 25 Legislature, 1st Called Session, hereby commend Father Jose
- 26 Alejandro Solalinde Guerra for his exceptional contributions in
- 27 behalf of human rights and extend to him sincere best wishes for
