2 executive officer of C. C. Young in June 2013, and it is most
3 fitting to take this opportunity to recognize him for his
4 impressive achievements; and

5 WHEREAS, A graduate of Wichita State University, Mr. Shields
6 served his country with distinction in the U.S. Air Force as a
7 transportation officer; during his 25-year military tenure, he
8 completed his MBA at the University of Oklahoma, and following his
9 retirement from the service, he returned to school, earning his
10 master's degree in gerontology from the University of North Texas;

23 sponsored by C. C. Young; he has also contributed to the Military
24 Officers Association of America in his role as secretary; and

2 dad, and grandpa in the world, Mr. Shields has shared 47 happy years
3 with his wife, Mary; they are the proud parents of three children
4 and dotting grandparents of six grandchildren; and

6 sometimes barista assistant, and all-around big cheese,
7 Mr. Shields is leaving a staff that will miss not only his
8 administrative abilities, but also his skill as an awards presenter
9 and his talent as grill master extraordinaire who has contributed
10 greatly to the fun of the annual picnics; along with all these
11 attributes, his dedication, professionalism, and commitment to
12 excellence have greatly benefited C. C. Young, and he may indeed
13 reflect with pride on a career well spent as he embarks on the next
14 exciting chapter of his life; now, therefore, be it
