1 WHEREAS, Benjamin Taylor Sharp graduated as the
2 valedictorian of the senior class of Borger High School on May 31,
3 2013; and

4 WHEREAS, Earning the title of valedictorian requires not only
5 intellect and aptitude, but also four years of dedication to the
6 highest academic standards; to attain this coveted distinction,
7 Mr. Sharp demonstrated a thorough understanding of a wide range of
8 subjects, and the rewards of the countless hours he has devoted to
9 his studies are myriad; and

10 WHEREAS, The son of Les and Melanie Sharp, Mr. Sharp has
11 ranked at the top of his class during all four years of high school;
12 he has been a frequent and highly accomplished UIL competitor in
13 mathematics, calculator, literary criticism, and editorial
14 writing, winning first-place honors at multiple events in each
15 category; moreover, he was recognized as a National Merit Scholar
16 Commended Student in his senior year while concurrently serving as
17 president of the National Honor Society and student council; and

9 hunger; an active congregant at Faith Covenant Church, he has
10 helped lead the youth group and shared his gifts as a vocalist,
11 guitarist, and keyboard player; and

12 WHEREAS, Mr. Sharp's truly outstanding efforts have won him a
13 host of awards, including a presidential scholarship to Texas Tech
14 University, where he plans to pursue degrees in economics and
15 English; and

16 WHEREAS, Throughout his academic career, Benjamin Sharp has
17 earned the respect and admiration of his teachers and classmates
18 alike, and his exceptional scholastic ability, hard work, and
19 commitment to excellence have opened the way to limitless
20 opportunities for this remarkable young Texan; now, therefore, be
