5	SECTION 1. Subtitle B, Title 5, Government Code, is amended
6	by adding Chapter 576 to read as follows:
7	CHAPTER 576. REIMBURSEMENT FOR STATE-FUNDED TRAVEL AND SECURITY
8	Sec. 576.001. DEFINITIONS. In this chapter:
9	(1) "Commission" means the Texas Ethics Commission.
10	(2) "Elected officer" means a member of the
11	legislature or the holder of an office of state government that is
12	voted on statewide, including a person appointed to fill a vacancy
13	in such an office.
14	Sec. 576.002. DISCLOSURE OF STATE-FUNDED TRAVEL OUTSIDE
15	THIS STATE. (a) An elected officer who uses any state funds for
16	transportation or security for travel outside this state shall file
17	a disclosure with the commission. A disclosure filed under this
18	chapter must be filed electronically.
19	(b) The disclosure must include:
20	(1) the dates on which the travel occurred;
21	(2) the locations where the travel occurred;
22	(3) the cost of the travel;
23	(4) the purpose of the travel; and
24	(5) the use to which the state-funded transportation

- 1 or security personnel was put.
- 2 Sec. 576.003. FILING DEADLINE. An elected officer shall
- 3 file a disclosure under this chapter not later than July 15 for
- 4 travel ending on or after January 1 and on or before June 30. An
- 5 elected officer shall file the disclosure not later than January 15
- 6 for travel ending on or after July 1 and on or before December 31 of
- 7 the previous year.
- 8 Sec. 576.004. COMMISSION REVIEW; REIMBURSEMENT. (a) The
- 9 commission shall review the disclosure not later than the 90th day
- 10 after the date the disclosure is filed.
- 11 (b) If the commission determines that the state-funded
- 12 <u>transportation or security was not used for</u> official state
- 13 business, the elected officer shall reimburse the state for the
- 14 cost of the travel plus interest calculated at a rate equal to
- 15 <u>inflation</u>.
- SECTION 2. Section 571.061(a), Government Code, is amended
- 17 to read as follows:
- 18 (a) The commission shall administer and enforce:
- 19 (1) Chapters 302, 303, 305, 572, <u>576</u>, and 2004;
- 20 (2) Subchapter C, Chapter 159, Local Government Code,
- 21 in connection with a county judicial officer, as defined by Section
- 22 159.051, Local Government Code, who elects to file a financial
- 23 statement with the commission;
- 24 (3) Title 15, Election Code; and
- 25 (4) Sections 2152.064 and 2155.003.
