- 6 quarter-century, he served his nation with great distinction as a
- 7 U.S. Army Ranger, Green Beret, and master parachutist infantry
- 8 officer; his assignments included commanding an airborne rifle
- 9 company, a Special Forces company, and a Special Forces A-team
- 10 responsible for a portable nuclear device; during his time in the
- 11 army, he furthered his military education at the U.S. Army Command
- 12 and General Staff College at Fort Leavenworth, Kansas, and earned a
- 13 master's degree in international relations from the University of
- 14 Southern California; and
- WHEREAS, After retiring from active duty in 1999 at the rank
- 16 of lieutenant colonel, this outstanding soldier was recalled to
- 17 service in 2002 for a period of 14 months; deployed to Afghanistan
- 18 and Qatar, he served on the staff of the Plans and Policy
- 19 Directorate of the U.S. Central Command under General Tommy Franks,
- 20 helping to plan the invasion of Iraq; and
- 21 WHEREAS, The extensive leadership skills that Keith Self
- 22 acquired during his military career have stood him in good stead in
- 23 his current position as county judge, the office to which he was
- 24 elected in 2006 and again in 2010; during his tenure, he has

- 4 responsibilities, Judge Self gives generously of his time as a

- 6 Prestonwood Pregnancy Center and as co-chair of the U.S. Army
- 7 Dallas Recruiting Battalion Advisory Board; he is also a member of
- 8 the McKinney Downtown Rotary Club; and
- 9 WHEREAS, Judge Self and his wife, Tracy, have shared a
- 10 devoted union of more than three decades; the couple are active
- 11 members of Stonebriar Community Church, where Mrs. Self works with
- 12 children with special needs; she also serves as children's director
- 13 for the McKinney/Allen Women's Group of Community Bible Study; and
- 14 WHEREAS, Keith Self's dedication, professionalism, and
- 15 commitment to his ideals have greatly benefited his nation, the
- 16 State of Texas, and the people of Collin County and have earned him
- 17 the lasting respect of his peers and the citizens he serves; now,
