1 WHEREAS, David Courreges has been honored as a 2013
2 Distinguished Law Graduate by the St. Mary's University School of
3 Law and the Law Alumni Association; and

4 WHEREAS, Mr. Courreges earned his bachelor's degree from The
5 University of Texas at Austin and went on to receive his master of
6 public administration degree and juris doctorate from St. Mary's
7 University; he has subsequently benefited St. Mary's as an adjunct
8 professor and as the on-site administrator of the Frank J. Madla
9 and Irma Rangel Legislative Internship Program, which he helped to
10 establish; he has further given back to the institution in his roles
11 as president of the law alumni association and as a member of the
12 university's board of trustees; and

13 WHEREAS, The founder of Courreges, PC, Mr. Courreges leads a
14 practice specializing in legislative and government affairs,
15 administrative and association law, and mediation; he has also
16 gained more than a decade of experience in government law, serving
17 as a legislative director for two state representatives, as general
18 counsel for nonpartisan legislative caucuses, and as a consultant
19 for a number of policy groups; and

20 WHEREAS, Mr. Courreges is an active and respected member of
21 his field; president of the Austin Young Lawyers Association, he
22 has served as vice president and board member of the state
23 organization and was involved in the development of several
24 law-focused education projects; his exceptional efforts earned him

3 and 2009; in addition, he has been recognized as the 2013 top young
4 Austinite in the legal profession by the Austin Under 40 committee,
5 and he has twice been honored by *Texas Monthly* as a Texas Rising
6 Star in government relations; and

7 WHEREAS, Despite his busy schedule, Mr. Courreges has made
8 time to serve his community, contributing to the Leukemia &
9 Lymphoma Society, The Settlement Home for Children, and Volunteer
10 Legal Services; and

11 WHEREAS, David Courreges has demonstrated exceptional
12 leadership, skill, and dedication in all of his endeavors, and he
13 may indeed reflect with great pride on his many achievements; now,
14 therefore, be it
