- 1 National Judicial College; he is a member of numerous bar
- 2 associations and a fellow of the Texas Bar Foundation; and
- 3 WHEREAS, Involved in his community as well, this esteemed
- 4 Texan has contributed to the Flaming Arrow District of the Boy
- 5 Scouts of America Sam Houston Area Council, the Houston Northwest
- 6 Chamber of Commerce, and the North Harris Montgomery Community
- 7 College Foundation; in addition, he has served as president of the
- 8 Sons of the American Revolution Paul Carrington Chapter and as
- 9 chancellor general of the national organization; and
- 10 WHEREAS, Tom Lawrence has greatly benefited his fellow Texans
- 11 through his dedication and commitment to excellence, and he may
- 12 indeed reflect with pride on his record of achievement as he embarks
