Amend SB 212 (senate committee printing) as follows:

(1) In SECTION 1 of the bill (page 1, lines 28 and 29), strike the amended heading to Chapter 81, Natural Resources Code, and substitute the following:

CHAPTER 81. TEXAS DEPARTMENT OF OIL AND GAS [RAILROAD COMMISSION OF TEXAS]

(2) In SECTION 2 of the bill (page 1, lines 32 through 36), strike amended Section 81.001, Natural Resources Code, and substitute the following:

Sec. 81.001. DEFINITIONS. In this chapter:

(1) "Commission" means the <u>Texas Department of Oil and</u> <u>Gas</u> [Railroad Commission of Texas].

(2) "Commissioner" means any member of the <u>Texas</u> <u>Department of Oil and Gas</u> [Railroad Commission of Texas].

(3) IN SECTION 3 of the bill (page 1, lines 39 through 47), strike added Section 81.003, Natural Resources Code, and substitute the following:

Sec. 81.003. TEXAS DEPARTMENT OF OIL AND GAS. (a) The Railroad Commission of Texas is renamed the Texas Department of Oil and Gas.

(b) A reference in law to:

(1) the Railroad Commission of Texas means the Texas Department of Oil and Gas; and

(2) a railroad commissioner or a member of the Railroad Commission of Texas means a member of the Texas Department of Oil and Gas.

(4) In SECTION 4 of the bill, in amended Section 81.01001, Natural Resources Code (page 1, lines 50 and 51), strike "<u>Energy</u> <u>Resources</u> [Railroad] Commission [of Texas]" and substitute "<u>Department of Oil and Gas</u> [Railroad Commission of Texas]".

(5) In SECTION 6 of the bill (page 2, line 68, through page3, line 4), strike amended Section 81.01005, Natural ResourcesCode, and substitute the following:

Sec. 81.01005. NAME AND SEAL. (a) The commissioners are known collectively as the "<u>Texas Department of Oil and Gas</u> [Railroad Commission of Texas]."

(b) The seal of the commission contains a star of five

points with the words "<u>Texas Department of Oil and Gas</u> [<del>Railroad</del> Commission of Texas</del>]" engraved on it.

(6) In SECTION 17 of the bill, in amended Section 52.092(c)(7), Election Code (page 6, line 56), strike "<u>energy</u> <u>resources</u>" and substitute "<u>oil and gas</u>".

(7) In SECTION 18 of the bill, in amended Section 756.126, Health and Safety Code (page 6, line 64), strike "<u>Energy Resources</u> [<u>Railroad</u>] Commission [<del>of Texas</del>]" and substitute "<u>Department of Oil</u> and Gas [<u>Railroad Commission of Texas</u>]".

(8) IN SECTION 22 of the bill (page 7, lines 57 and 58), strike "Energy Resources Commission" and substitute "Department of Oil and Gas".
