1 Amend C.S.H.B. No. 2197 (house committee report) by adding  
2 the following appropriately numbered SECTIONS to the bill and  
3 renumbering subsequent SECTIONS of the bill accordingly:

4 SECTION \_\_. Section 466.408(b), Government Code, is  
5 amended to read as follows:

6 (b) If a claim is not made for prize money on or before  
7 the 180th day after the date on which the winner was selected,  
8 the prize money shall be used in the following order of  
9 priority:

10 (1) subject to legislative appropriation, not more  
11 than \$20 million in prize money each year may be deposited to  
12 ~~[or appropriated from]~~ the [Texas] Department of State Health  
13 Services state-owned multicategorical teaching hospital account,  
14 which is an account in the general revenue fund, or appropriated  
15 from that account to provide indigent health care services as  
16 specified in Chapter 61, Health and Safety Code;

17 (2) not more than \$5 million in prize money each year  
18 may be appropriated to the Health and Human Services Commission  
19 and shall be used to support the provision of inpatient hospital  
20 services in hospitals located in the 15 counties that comprise  
21 the Texas-Mexico border area, with payment for those services to  
22 be not less than the amount established under the Tax Equity and  
23 Fiscal Responsibility Act of 1982 (TEFRA) cost reimbursement  
24 methodology for the hospital providing the services;

25 (3) the remaining amount, not to exceed \$5 million in  
26 prize money in each state fiscal year less any amount deposited  
27 in the fund in that year attributable to the lottery game  
28 operated under Section 466.027, shall be deposited to the fund  
29 for veterans' assistance; and

1           (4) all prize money subject to this section and not  
2 deposited or appropriated in accordance with [~~from the Texas~~  
3 ~~Department of Health state-owned multicategorical teaching~~  
4 ~~hospital account, not appropriated to the Health and Human~~  
5 ~~Services Commission for the purpose specified in~~] Subdivision  
6 (1), (2), or [~~and not deposited under Subdivision~~] (3) [~~7~~] shall  
7 be deposited to the credit of the foundation school [~~in the~~  
8 ~~general revenue~~] fund [~~and may be appropriated for any purpose~~  
9 ~~as determined by the legislature, including the provision of~~  
10 ~~indigent health care services as specified in Chapter 61, Health~~  
11 ~~and Safety Code~~].

12           SECTION \_\_. Section 466.408(b), Government Code, as  
13 amended by this Act, applies only to a prize for which the  
14 winner is selected on or after September 1, 2013. A prize for  
15 which the winner was selected before September 1, 2013, is  
16 governed by the law as it existed immediately before the  
17 effective date of this Act, and that law is continued in effect  
18 for that purpose.
