1 Amend C.S.S.B. No. 219 (house committee report) in Article 4
2 of the bill by inserting the following new SECTION, appropriately
3 numbered, and renumbering the subsequent SECTIONS accordingly:

4 SECTION 4.____. Subsection (a), Section 254.031, Election
5 Code, is amended to read as follows:

6 (a) Except as otherwise provided by this chapter, each
7 report filed under this chapter must include:

8 (1) the amount of political contributions from each
9 person that in the aggregate exceed \$50 and that are accepted during
10 the reporting period by the person or committee required to file a
11 report under this chapter, the full name and address of the person
12 making the contributions, and the dates of the contributions;

13 (2) the amount of loans that are made or outstanding
14 during the reporting period for campaign or officeholder purposes
15 to the person or committee required to file the report and that in
16 the aggregate exceed \$50, the dates the loans are made, the interest
17 rate, the maturity date, the type of collateral for the loans, if
18 any, the full name and address of the person or financial
19 institution making the loans, the full name and address, principal
20 occupation, and name of the employer of each guarantor of the loans,
21 the amount of the loans guaranteed by each guarantor, and the
22 aggregate principal amount of all outstanding loans as of the last
23 day of the reporting period;

24 (3) the amount of political expenditures that in the
25 aggregate exceed \$100 and that are made during the reporting
26 period, the full name and address of the persons to whom the
27 expenditures are made, and the dates and purposes of the
28 expenditures;

29 (4) the amount of each payment made during the

1 reporting period from a political contribution if the payment is
2 not a political expenditure, the full name and address of the person
3 to whom the payment is made, and the date and purpose of the
4 payment;

5 (5) the total amount or a specific listing of the
6 political contributions of \$50 or less accepted and the total
7 amount or a specific listing of the political expenditures of \$100
8 or less made during the reporting period;

9 (6) the total amount of all political contributions
10 accepted and the total amount of all political expenditures made
11 during the reporting period;

12 (7) the name of each candidate or officeholder who
13 benefits from a direct campaign expenditure made during the
14 reporting period by the person or committee required to file the
15 report, and the office sought or held, excluding a direct campaign
16 expenditure that is made by the principal political committee of a
17 political party on behalf of a slate of two or more nominees of that
18 party;

19 (8) as of the last day of a reporting period for which
20 the person is required to file a report, the total amount of
21 political contributions accepted, including interest or other
22 income on those contributions, maintained in one or more accounts
23 in which political contributions are deposited as of the last day of
24 the reporting period;

25 (9) any credit, interest, rebate, refund,
26 reimbursement, or return of a deposit fee resulting from the use of
27 a political contribution or an asset purchased with a political
28 contribution that is received during the reporting period and the
29 amount of which exceeds \$100;

30 (10) any proceeds of the sale of an asset purchased
31 with a political contribution that is received during the reporting

1 period and the amount of which exceeds \$100;

2 (11) any investment purchased with a political
3 contribution that is received during the reporting period and the
4 amount of which exceeds \$100;

5 (12) any other gain from a political contribution that
6 is received during the reporting period and the amount of which
7 exceeds \$100; and

8 (13) the full name and address of each person from whom
9 an amount described by Subdivision (9), (10), (11), or (12) is
10 received, the date the amount is received, and the purpose for which
11 the amount is received.
