# **BILL ANALYSIS**

C.S.H.B. 3875 By: Raney Special Purpose Districts Committee Report (Substituted)

## BACKGROUND AND PURPOSE

There is currently certain developed commercial property within the corporate limits of the City of College Station in Brazos County. C.S.H.B. 3875 seeks to create a management district over this property to administer and provide funding for economic development projects and services in the district.

### **RULEMAKING AUTHORITY**

It is the committee's opinion that this bill does not expressly grant any additional rulemaking authority to a state officer, department, agency, or institution.

### ANALYSIS

C.S.H.B. 3875 amends the Special District Local Laws Code to create the Rock Prairie Management District No. 1 to provide certain improvements, projects, and services for public use and benefit. The bill provides for, among other provisions, the annexation of land. The district's powers and duties include the authorization to issue obligations and impose assessments. The district is prohibited from exercising the power of eminent domain and from imposing a property tax.

### EFFECTIVE DATE

On passage, or, if the bill does not receive the necessary vote, September 1, 2013.

### **COMPARISON OF ORIGINAL AND SUBSTITUTE**

While C.S.H.B. 3875 may differ from the original in minor or nonsubstantive ways, the following comparison is organized and highlighted in a manner that indicates the substantial differences between the introduced and committee substitute versions of the bill.
