- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 31.021(b), Parks and Wildlife Code, is
- 5 amended to read as follows:
- 6 (b) No person may operate or give permission for the
- 7 operation of any vessel or may dock, moor, or store a vessel owned
- 8 by the person on the water of this state unless:
- 9 (1) the vessel is numbered as required by this
- 10 chapter;
- 11 (2) the certificate of number awarded to the vessel is
- 12 in full force and effect; and
- 13 (3) the identifying number set forth in the
- 14 certificate is properly displayed on [each side of the bow of] the
- 15 vessel as required by this chapter.
- 16 SECTION 2. The heading to Section 31.032, Parks and
- 17 Wildlife Code, is amended to read as follows:
- 18 Sec. 31.032. NUMBERING LOCATION AND VISIBILITY; EXEMPTION;
- 19 <u>DECAL</u> [<del>ON BOW</del>].
- SECTION 3. Section 31.032, Parks and Wildlife Code, is
- 21 amended by amending Subsections (a) and (c) and adding Subsection
- 22 (a-1) to read as follows:
- 23 (a) The owner of a vessel shall paint on or attach to each
- 24 side of the forward half of the vessel [near the bow] the

- 1 identification number and a <u>registration</u> [validation] decal in the
- 2 manner prescribed by the department. The number shall read from
- 3 left to right and shall be of block characters of good proportion of
- 4 not less than three inches in height. The numbers shall be of a
- 5 color which will contrast with the hull material of the vessel and
- 6 so maintained as to be clearly visible and legible.
- 7 (a-1) On a vessel configured so that a number on the hull or
- 8 superstructure is not easily visible, the number must be painted on
- 9 or attached to a backing plate that is attached to the forward half
- 10 of the vessel so that the number is visible from each side of the
- 11 vessel.
- 12 (c) The commission shall adopt rules for the placement of
- 13 the registration [validation] decal in an alternate location for
- 14 antique boats. In this subsection, "antique boat" means a boat
- 15 that:
- 16 (1) is used primarily for recreational purposes; and
- 17 (2) was manufactured 35 or more years before the date
- 18 the registration [validation] decal is issued.
- 19 SECTION 4. Sections 31.033(a) and (b), Parks and Wildlife
- 20 Code, are amended to read as follows:
- 21 (a) No person may paint, attach, or otherwise display on the
- 22 forward half [either side of the bow] of a vessel a number other
- 23 than the number awarded to the vessel or granted reciprocity under
- 24 this chapter.
- 25 (b) No person may deface or alter the certificate of number
- 26 or the number assigned to and appearing on [the bow of] a vessel.
- 27 SECTION 5. This Act takes effect September 1, 2013.
