20	financial incentives under this subchapter, a person must:
21	(1) apply to the board in the form and manner

23	(2) have completed at least 60 semester credit hours

1 college or a junior college accredited by a recognized accrediting 2 agency; 3 (3) be admitted into an educator preparation program at an institution of higher education or at a private or independent 4 5 institution of higher education that prepares students for certification to teach bilingual education, English as a second 6 7 language, or Spanish; 8 (4) enter into an agreement with the board as provided by Section 61.9823; and 9 10 (5) satisfy any other criteria jointly prescribed by the board and the State Board for Educator Certification. 11 12 Sec. 61.9823. AGREEMENT. To qualify for financial incentives under this subchapter, a person must enter into a 13 14 written agreement with the board as provided by this section. The 15 agreement must require the person to: 16 (1) obtain, within the period prescribed by board 17 rule, certification to teach bilingual education, English as a second language, or Spanish in a public elementary or secondary 18 19 school in this state; (2) accept, during the first school year that begins 20 after the date the person becomes certified as provided by 21 Subdivision (1), an offer of full-time employment to teach 22 bilingual education, English as a second language, or Spanish in a 23 24 public elementary or secondary school in this state that has a shortage of teachers certified to teach in one or more of those 25 26 fields; and 27 (3) teach bilingual education, English as a second

1 language, or Spanish at that school for at least two school years. 2 Sec. 61.9824. FINANCIAL INCENTIVES. The board shall award 3 financial incentives such as tuition assistance or student loan repayment to each participant in the program to assist with the cost 4 of payment of mandatory tuition and fees for courses required to 5 obtain certification to teach bilingual education, English as a 6 7 second language, or Spanish. 8 Sec. 61.9825. REIMBURSEMENT; EXCEPTIONS. (a) A program participant who fails to meet the requirements of Section 61.9823 9 10 shall reimburse the board for the amount of any assistance received by the participant under this subchapter. 11 12 (b) The board by rule shall establish exceptions to the reimbursement requirement under this section for participants who 13 are unable to meet the requirements of Section 61.9823 as a result 14 of an unusual hardship. 15 Sec. 61.9826. GIFTS, GRANTS, AND DONATIONS. In addition to 16 money appropriated by the legislature, the board may solicit and 17 accept gifts, grants, and donations for the purposes of this 18 19 subchapter. Sec. 61.9827. RULES. The board shall adopt rules necessary 20 for the administration of this subchapter, including a rule that 21 sets the maximum amount of financial assistance that a person may 22 receive under this subchapter in one year. 23 24 SECTION 2. The Texas Higher Education Coordinating Board

25 shall adopt rules for the administration of Subchapter II, Chapter 26 61, Education Code, as added by this Act, as soon as practicable 27 after this Act takes effect. For that purpose, the coordinating

1 board may adopt the initial rules in the manner provided by law for 2 emergency rules.

3 SECTION 3. This Act takes effect immediately if it receives 4 a vote of two-thirds of all the members elected to each house, as 5 provided by Section 39, Article III, Texas Constitution. If this 6 Act does not receive the vote necessary for immediate effect, this 7 Act takes effect September 1, 2013.
