- (b) A political subdivision shall provide to the 11

- published by the political subdivision in a newspaper. The 13
- 14 political subdivision must submit the notice to the comptroller in
- the format required by the comptroller not later than the third day 15

- 7 which the political subdivision's notices may be located.
- 8 (d) The comptroller shall establish and maintain a web page

- 13 political subdivision provides the notice to the comptroller.
- 14 (e) The comptroller shall establish a system to allow a
- 15 person on request to receive an e-mail alert for an update to a

- 19 (f) The comptroller may adopt rules necessary to implement
