- SECTION 2. Section 2308.455, Occupations Code, is amended

- 18 Sec. 2308.455. CONTENTS OF NOTICE. The notice under
- 19 Section 2308.454 must include:

- 21 (A) the person's right to submit a request within

- 9 (3) the name, address, [and] telephone number, and
- 10 county of the vehicle storage facility in which the vehicle was
- 11 placed;
- 12 (4) the name, street address including city, state,
- 13 and zip code, and telephone number of the person, parking facility
- 14 owner, or law enforcement agency that authorized the removal of the
- 15 vehicle; and
- 16 (5) the name, address, and telephone number of each
- 17 [the] justice court having jurisdiction in the county from
- 18 [precinct in] which the vehicle was towed, or the address of an
- 19 Internet website maintained by the Office of Court Administration
- 20 of the Texas Judicial System that contains the name, address, and
- 21 telephone number of each justice court having jurisdiction in the

- SECTION 3. The change in law made by this Act applies only
- 25 to a cause of action filed on or after the effective date of this
- 26 Act. A cause of action filed before the effective date of this Act
- 27 is governed by the law in effect on the date the action was filed,

- 1 and the former law is continued in effect for that purpose.
- 2 SECTION 4. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2013.
