Section 306.003, Government Code, is amended by 6 adding Subsections (c) and (d) to read as follows: 7 (c) If a member of the legislature or the lieutenant 8 9 governor discloses to the Department of Family and Protective Services or a governmental unit that is a "covered entity" under 10 Section 181.001(b), Health and Safety Code, all or part of a record 11 12 to which Subsection (a) applies or communicates to the department or governmental unit a description of the information contained in 13 14 the record that identifies or would tend to identify the resident of this state who communicated with the member or lieutenant governor, 15 the record or the described information, as applicable, in the 16 possession of the department or governmental unit is subject to and 17 confidential under Subsection (a) and may be disclosed to any other 18 person only to the extent that the member of the legislature or 19 lieutenant governor elects to disclose the record or the described 20 21 information. 22 (d) If the department or governmental unit that is a 23 "covered entity" under Section 181.001(b), Health and Safety Code,

24 receives a request for public information under Chapter 552, and

1 information subject to the request is information described by 2 Subsection (c), the department or governmental unit shall promptly notify, in writing or by electronic means, the member of the 3 legislature or the lieutenant governor, as applicable, that the 4 department or governmental entity received the request. The 5 notification must specify the type of information that is requested 6 7 and include a copy of the request. 8 SECTION 2. Section 306.004, Government Code, is amended by adding Subsections (d) and (e) to read as follows: 9 (d) If a member of the legislature or the lieutenant 10 governor discloses to the Department of Family and Protective 11 Services or a governmental unit that is a "covered entity" under 12 Section 181.001(b), Health and Safety Code, a communication to 13 14 which this section applies or communicates to the department or 15 governmental unit a description of the information contained in the communication that identifies or would tend to identify the citizen 16 17 of this state who communicated with the member or lieutenant governor, the communication or the described information, as 18 19 applicable, in the possession of the department or governmental unit is subject to and confidential under this section and may be 20 disclosed to another person only to the extent that the member of 21 the legislature or lieutenant governor elects to disclose the 22 23 communication or the described information. 24 (e) If the department or governmental unit that is a

Subsection (d), the department or governmental unit shall promptly 1 2 notify, in writing or by electronic means, the member of the legislature or the lieutenant governor, as applicable, that the 3 department or governmental entity received the request. The 4 notification must specify the type of information that is requested 5 6 and include a copy of the request. 7 SECTION 3. This Act takes effect immediately if it receives 8 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this 9

10 Act does not receive the vote necessary for immediate effect, this
11 Act takes effect September 1, 2013.
