- 4 SECTION 2. Subchapter D, Chapter 801, Occupations Code, is
- 5 amended by adding Section 801.163 to read as follows:
- 6 Sec. 801.163. PEACE OFFICERS. (a) The board may commission
- 7 as a peace officer to enforce this chapter an employee who has been
- 8 certified as qualified to be a peace officer by the Commission on
- 9 Law Enforcement Officer Standards and Education.
- 10 (b) An employee commissioned as a peace officer under this
- 11 chapter has the powers, privileges, and immunities of a peace
- 12 officer while carrying out duties as a peace officer under this
- 13 chapter.
- 14 SECTION 3. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2013.
