AN ACT

- 2 relating to authorization for a caregiver who is a relative to
- 3 enroll a child in school.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subtitle A, Title 2, Family Code, is amended by
- 6 adding Chapter 35 to read as follows:
- 7 CHAPTER 35. RIGHTS OF CERTAIN RELATIVE CAREGIVERS TO ENROLL CHILD
- 8 IN SCHOOL
- 9 Sec. 35.001. DEFINITION. In this chapter, "relative" means
- 10 someone related to a child by consanguinity or affinity, as
- 11 determined under Sections 573.022 and 573.024, Government Code,
- 12 <u>respectively.</u>
- 13 Sec. 35.002. AFFIDAVIT OF CAREGIVER. (a) A caregiver of a
- 14 child who is a relative of the child may execute an affidavit
- 15 indicating that:
- 16 (1) the child primarily resides with the caregiver;
- 17 and

- 18 (2) the caregiver made a reasonably diligent effort
- 19 but was unable to locate or contact the child's parent or legal
- 20 guardian for authorization.
- 21 (b) The affidavit must be witnessed by two witnesses who are
- 22 at least 18 years of age or older and at least one of whom is not
- 23 related by blood or marriage to the child or the caregiver.
- (c) The completed affidavit must be notarized.

- 1 Sec. 35.003. RIGHTS AND DUTIES OF CHILD AND CAREGIVER. (a)
- 2 A caregiver may provide the affidavit under this chapter to a school
- 3 or school district to enroll the child in school.
- 4 (b) If the child no longer resides with the caregiver or if
- 5 the child's parent or guardian objects to the caregiver's
- 6 authorization, the affidavit is invalid and the caregiver shall
- 7 notify all parties to whom the caregiver provided the affidavit,
- 8 including the child's school.
- 9 Sec. 35.004. EFFECT OF AFFIDAVIT. (a) A person who relies
- 10 on an affidavit that complies with this chapter has no obligation to
- 11 make any further inquiry or investigation.
- 12 (b) The caregiver's authorization affidavit does not affect
- 13 the rights of the child's parent or legal guardian regarding the
- 14 care, custody, and control of the child and does not mean that the
- 15 <u>caregiver has legal custody of the child.</u>
- 16 (c) A caregiver's authorization affidavit executed under
- 17 this chapter does not confer or affect standing or a right of
- 18 intervention in any proceeding under Title 5.
- 19 Sec. 35.005. FORM OF AFFIDAVIT. The caregiver's
- 20 authorization affidavit must be in substantially the following
- 21 <u>form:</u>
- 22 <u>Caregiver's Authorization Affidavit</u>
- Use of this affidavit is authorized by Chapter 35, Family
- 24 Code.
- 25 <u>Instructions: Completion of and the signing of the affidavit</u>
- 26 are sufficient to authorize enrollment of a child in school. Print
- 27 clearly.

27	1. "Qualified relative," for purposes of item 5 of the

- 1 affidavit, means a person related to the child by consanguinity or
- 2 affinity (blood, marriage, or adoption).
- 3 2. If the child no longer resides with you, or if the child's
- 4 parent or guardian objects to this authorization, you are required
- 5 to notify any school to which you have given this affidavit. The
- 6 affidavit is invalid after the school receives notice.
- 7 TO SCHOOL OFFICIALS:
- 8 <u>1. Section 25.001, Education Code, provides that this</u>
- 9 affidavit constitutes a sufficient basis for a determination of
- 10 residency of the child, without the requirement of a guardianship
- 11 or other custody order, unless the school district determines from
- 12 actual facts that the child is not living with the caregiver.
- 13 2. The school district may require additional reasonable
- 14 evidence that the caregiver lives at the address provided in item 4
- 15 of the affidavit.
- Sec. 35.006. RULES. (a) The commissioner of education
- 17 shall adopt rules to implement this chapter and to ensure that the
- 18 caregiver's authorization affidavit is accepted by schools and
- 19 school districts.
- 20 (b) The Texas Education Agency shall develop the form
- 21 required by Section 35.005 and make that form available on the
- 22 <u>agency's Internet website.</u>
- 23 SECTION 2. Section 25.001(b), Education Code, is amended to
- 24 read as follows:
- 25 (b) The board of trustees of a school district or its
- 26 designee shall admit into the public schools of the district free of
- 27 tuition a person who is over five and younger than 21 years of age on

- 1 the first day of September of the school year in which admission is
- 2 sought, and may admit a person who is at least 21 years of age and
- 3 under 26 years of age for the purpose of completing the requirements
- 4 for a high school diploma, if:
- 5 (1) the person and either parent of the person reside
- 6 in the school district;
- 7 (2) the person does not reside in the school district
- 8 but a parent of the person resides in the school district and that
- 9 parent is a joint managing conservator or the sole managing
- 10 conservator or possessory conservator of the person;
- 11 (3) the person and the person's guardian or other
- 12 person having lawful control of the person under a court order
- 13 reside within the school district;
- 14 (4) the person has established a separate residence
- 15 under Subsection (d);
- 16 (5) the person is homeless, as defined by 42 U.S.C.
- 17 Section 11302, regardless of the residence of the person, of either
- 18 parent of the person, or of the person's guardian or other person
- 19 having lawful control of the person;
- 20 (6) the person is a foreign exchange student placed
- 21 with a host family that resides in the school district by a

- 12 SECTION 3. Section 25.002(f), Education Code, is amended to
- 13 read as follows:
- 14 (f) [Except as otherwise provided by this subsection, for a
- 15 child to be enrolled in a public school, the child must be enrolled
- 16 by the child's parent or by the child's guardian or other person
- 17 with legal control of the child under a court order. A school
- 18 district shall record the name, address, and date of birth of the
- 19 person enrolling a child.
- SECTION 4. Section 26.002, Education Code, is amended to
- 21 read as follows:
- Sec. 26.002. DEFINITION. In this chapter, "parent"
- 23 includes a person standing in parental relation. The term includes
- 24 a relative with whom the child resides and who is authorized to
- 25 enroll the child in school pursuant to an authorization agreement
- 26 <u>executed under Chapter 34</u>, Family Code, or a caregiver's
- 27 authorization affidavit executed under Chapter 35, Family Code.

- 1 The term does not include a person as to whom the parent-child
- 2 relationship has been terminated or a person not entitled to
- 3 possession of or access to a child under a court order. Except as
- 4 provided by federal law, all rights of a parent under Title 2 of
- 5 this code and all educational rights under Section 151.001(a)(10)
- 6 $[\frac{151.003(a)(10)}{}]$, Family Code, shall be exercised by a student who
- 7 is 18 years of age or older or whose disabilities of minority have
- 8 been removed for general purposes under Chapter 31, Family Code,
- 9 unless the student has been determined to be incompetent or the
- 10 student's rights have been otherwise restricted by a court order.
- 11 SECTION 5. Sections 25.001, 25.002, and 26.002, Education
- 12 Code, as amended by this Act, apply beginning with the 2013-2014
- 13 school year.
- 14 SECTION 6. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2013.
