22	SECTION 2. Section 502.255(i), Transportation Code, is

trailer registered under this section that does not expire or 1 require an annual registration insignia to be valid. 2 The alphanumeric pattern for a license plate issued under this 3 subsection may remain on a token trailer for as long as the 4 registration of the token trailer is renewed or until the token 5 6 trailer is removed from service or sold. The registration receipt required under Section 621.002 is not required for a vehicle that 7 displays a license plate issued under this subsection [may issue 8 specially designed license plates for token trailers]. 9

10 SECTION 3. The Texas Department of Motor Vehicles shall 11 adopt rules for the administration of Sections 502.0023 and 12 502.255(i), Transportation Code, as amended by this Act, as soon as 13 practicable after this Act takes effect. For that purpose, the 14 department may adopt the rules in the manner provided by law for 15 emergency rules.

16 SECTION 4. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2013.
