A BILL TO BE ENTITLED

- 2 relating to the number of license plates to be issued for and
- 3 displayed on certain motor vehicles.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 504, Transportation Code,
- 6 is amended by adding Section 504.011 to read as follows:
- 7 Sec. 504.011. ISSUANCE AND DISPLAY OF LICENSE PLATE FOR
- 8 PASSENGER CAR OR LIGHT TRUCK. (a) Notwithstanding anything in this
- 9 code to the contrary, the department shall issue only one license
- 10 plate for attachment at the rear of a passenger car or light truck
- 11 for which the plate is issued.
- 12 (b) Notwithstanding anything in this code to the contrary, a
- 13 person is entitled to operate on a public highway a passenger car or
- 14 light truck that displays only one license plate if the plate is
- 15 attached at the rear of the vehicle. A person may operate on a
- 16 public highway a passenger car or light truck that displays two
- 17 license plates if both plates were assigned by the department for
- 18 the registration period as a set of plates.
- (c) In any provision of this code that relates to the
- 20 issuance or display of "license plates," "plates," or a "set of
- 21 plates" for a passenger car or light truck, the term means only one
- 22 <u>license plate.</u>
- SECTION 2. Section 504.943, Transportation Code, is amended
- 24 by amending Subsection (b) and adding Subsection (e) to read as

- 1 follows:
- 2 (b) A person commits an offense if the person operates on a
- 3 public highway during a registration period a passenger car, light
- 4 <u>truck</u>, road tractor, motorcycle, trailer, or semitrailer that does
- 5 not display a license plate that:
- 6 (1) has been assigned by the department for the
- 7 period; and
- 8 (2) complies with department rules regarding the
- 9 placement of license plates.
- 10 (e) In this section, "light truck" and "passenger car" have
- 11 the meanings assigned by Section 541.201.
- 12 SECTION 3. The change in law made by this Act regarding the
- 13 issuance of license plates by the Texas Department of Motor
- 14 Vehicles applies only to the issuance of license plates by the
- 15 department for a registration period beginning on or after the
- 16 effective date of this Act. For a registration period that begins
- 17 before the effective date of this Act, the department shall issue
- 18 license plates as required by the law in effect immediately before
- 19 the effective date of this Act, and the former law is continued in
- 20 effect for that purpose.
- 21 SECTION 4. This Act takes effect September 1, 2013.
