A BILL TO BE ENTITLED

- 2 relating to commissioners court oversight of certain emergency
- 3 services districts.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 775, Health and Safety Code, is amended
- 6 by adding Subchapter K to read as follows:

7 <u>SUBCHAPTER K. DISTRICTS IN CERTAIN COUNTIES</u>

- 8 Sec. 775.301. DEFINITION. In this subchapter,
- 9 "commissioners court" means the commissioners court of a county
- 10 that borders the United Mexican States and has a population of more
- 11 than 800,000.
- 12 Sec. 775.302. APPLICABILITY; SUBCHAPTER SUPERSEDES. (a)
- 13 This subchapter applies only to a district that is located wholly or
- 14 partly in a county that borders the United Mexican States and has a
- 15 population of more than 800,000.
- 16 (b) This subchapter controls over a provision of this
- 17 chapter or other law to the extent of a conflict.
- 18 <u>Sec. 775.303. POWERS RELATING TO DISTRICT PROPERTY,</u>
- 19 FACILITIES, AND EQUIPMENT. (a) With the approval of the
- 20 commissioners court, the board may construct, acquire, lease, add
- 21 to, maintain, operate, develop, regulate, sell, exchange, and
- 22 convey any property, property right, equipment, facility, or system
- 23 to maintain a building or other facility or to provide a service
- 24 required by the district.

- (b) Notwithstanding any other law, the board may, with the 1 2 approval of the commissioners court, lease undeveloped real property for not more than 50 years to provide for the development 3 and construction of facilities designed to generate revenue for the 4 financial benefit of the district. The board, directly or through 5 a nonprofit corporation, may contract or enter into a joint venture 6 7 with a public or private entity as necessary to enter into a lease 8 under this subsection.
- 9 (c) The board may not borrow money or make other financial
 10 arrangements under Section 775.085 unless the commissioners court
 11 approves the transaction.
- 12 <u>Sec. 775.304. CONTRACTING AUTHORITY.</u> (a) With the
 13 <u>approval of the commissioners court, the board may, in performing</u>
 14 its powers under Section 775.303, contract or cooperate with:
- 15 <u>(1) the federal government;</u>
- 16 <u>(2) this state;</u>
- 17 (3) another governmental entity; or
- 18 (4) a privately owned or operated hospital.
- (b) The district may not enter into a contract with a local government under Section 775.0366 unless the commissioners court approves that contract.
- (c) The board shall encourage and promote participation by
 all sectors of the business community, including small businesses
 and businesses owned by members of a minority group or by women, in
 the process by which the district enters into contracts. The board
 shall develop a plan for the district to identify and remove
 barriers that do not have a definite or objective relationship to

- 1 quality or competence and that unfairly discriminate against small
- 2 businesses and businesses owned by members of a minority group or by
- 3 women. These barriers may include contracting procedures and
- 4 contract specifications or conditions.
- 5 Sec. 775.305. COUNTY AUTHORITY TO SELL, LEASE, AND PURCHASE
- 6 FACILITIES FOR DISTRICT PURPOSES. (a) The commissioners court may
- 7 sell real or personal property in order to enter into a contract to:
- 8 (1) lease or rent buildings, land, facilities,
- 9 equipment, or services from others for district purposes;
- 10 (2) construct, repair, renovate, improve, or enlarge
- 11 buildings, land, facilities, or equipment for district purposes;
- 12 and
- 13 (3) pay regular monthly utility bills, including
- 14 electricity, gas, and water bills, for the leased or rented
- 15 <u>buildings</u>, land, facilities, equipment, or services.
- 16 (b) The commissioners court may pay for the facilities,
- 17 equipment, and services and for the regular monthly utility bills
- 18 for those facilities, equipment, and services from the county's
- 19 general fund if a majority of the commissioners court considers the
- 20 facilities, equipment, and services essential to the proper
- 21 administration of the county.
- (c) A construction project under this section shall be let
- 23 by contract. The contract must contain the prevailing wage for
- 24 mechanics, laborers, and other persons employed in the project.
- 25 (d) On or before the expiration of the lease or rental
- 26 contract, the county may purchase the facilities with county
- 27 general funds if a majority of the commissioners court considers

- 1 <u>the purchase price reasonable.</u>
- 2 Sec. 775.306. PURCHASING PROCEDURES. A district shall
- 3 purchase items in accordance with the same procedures and subject
- 4 to the same requirements applicable to a county under Subchapter C,
- 5 Chapter 262, Local Government Code. For the purposes of this
- 6 section, a district is treated as if it were a county.
- 7 Sec. 775.307. BUDGET. The board shall prepare an annual
- 8 budget. The board shall present the annual budget to the
- 9 commissioners court for final approval.
- Sec. 775.308. AD VALOREM TAX. (a) With respect to the
- 11 imposition or collection of an ad valorem tax imposed for the
- 12 benefit of a district to which this subchapter applies, the
- 13 commissioners court has the authority assigned by law to the board
- 14 of the district, including the authority to:
- (1) adopt an exemption, partial exemption, or other
- 16 form of relief from an ad valorem tax;
- 17 (2) elect to tax property that would otherwise be
- 18 exempt from an ad valorem tax;
- 19 (3) exercise a power granted to a taxing unit under
- 20 Section 6.30, Tax Code; and
- 21 (4) determine whether the district may call an
- 22 <u>election under Section 775.0745 to increase the district's tax</u>
- 23 <u>rate.</u>
- 24 (b) The board of a district to which this subchapter applies
- 25 may not exercise a power granted by Subsection (a) to the
- 26 commissioners court with respect to the imposition or collection of
- 27 an ad valorem tax imposed for the benefit of the district.
