- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 43.112, Government Code, is amended to
- 8 read as follows:
- 9 Sec. 43.112. 25TH JUDICIAL DISTRICT. The voters of
- 10 [Gonzales,] Guadalupe County [, and Lavaca counties] elect a
- 11 district attorney for the 25th Judicial District who represents the
- 12 state in the [that] district courts in Guadalupe County [court only
- 13 in those counties]. In addition to exercising the duties and
- 14 authority conferred on district attorneys by general law, the
- 15 district attorney represents the state in all criminal cases in the
- 16 district courts in that county [those counties].

- 22 Swisher, Terry, Webb, and Willacy.
- 23 SECTION 5. This Act takes effect September 1, 2013.
