## A BILL TO BE ENTITLED

- 2 relating to the eligibility requirements for occupational licenses
- 3 issued to applicants with military experience and to military
- 4 spouses.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter H, Chapter 51, Occupations Code, is
- 7 amended by adding Section 51.4013 to read as follows:
- 8 Sec. 51.4013. LICENSE ELIGIBILITY REQUIREMENTS FOR
- 9 APPLICANTS WITH MILITARY EXPERIENCE. (a) Notwithstanding any other
- 10 law, the department shall credit verified military service,
- 11 training, or education toward the licensing requirements, other
- 12 than examination requirements, for a license issued by the
- 13 <u>department</u>.
- 14 (b) The department shall expedite the issuance of a
- 15 temporary license or a license by endorsement or reciprocity to an
- 16 applicant who:
- 17 (1) has verified military experience; and
- 18 (2) holds a current license issued by another
- 19 jurisdiction that has license requirements that are substantially
- 20 equivalent to the license requirements of this state.
- 21 <u>(c) The commission shall adopt rules necessary to implement</u>
- 22 this section.
- SECTION 2. The heading to Chapter 55, Occupations Code, is
- 24 amended to read as follows:

- 1 CHAPTER 55. LICENSE FOR [WHILE ON] MILITARY SERVICE MEMBER OR [DUTY
- 2 AND FOR MILITARY SPOUSE
- 3 SECTION 3. Section 55.004, Occupations Code, is amended by
- 4 adding Subsection (d) to read as follows:
- 5 (d) A state agency shall adopt rules to expedite the
- 6 <u>issuance of a temporary license or a license by endorsement or</u>
- 7 reciprocity to an applicant who:
- 8 <u>(1) is the spouse of a person serving on active duty as</u>
- 9 a member of the armed forces of the United States; and
- 10 (2) holds a current license issued by another
- 11 jurisdiction that has license requirements that are substantially
- 12 equivalent to the license requirements of this state.
- 13 SECTION 4. Chapter 55, Occupations Code, is amended by
- 14 adding Section 55.005 to read as follows:
- 15 Sec. 55.005. LICENSE ELIGIBILITY REQUIREMENTS FOR
- 16 APPLICANTS WITH MILITARY EXPERIENCE. (a) Notwithstanding any other
- 17 law, a state agency shall credit verified military service,
- 18 training, or education toward the licensing requirements, other
- 19 than examination requirements, for a license issued by the state
- 20 agency.
- 21 (b) The state agency shall expedite the issuance of a

- 1 (c) The state agency shall adopt rules necessary to
- 2 <u>implement this section</u>.
- 3 SECTION 5. (a) Sections 51.4013, 55.004(d), and 55.005,
- 4 Occupations Code, as added by this Act, apply only to an application
- 5 for an occupational license filed on or after May 1, 2014. An
- 6 application for a license filed before May 1, 2014, is governed by
- 7 the law in effect on the date the application was filed, and that
- 8 law is continued in effect for that purpose.
- 9 (b) The Texas Commission of Licensing and Regulation shall
- 10 adopt rules under Section 51.4013, Occupations Code, as added by
- 11 this Act, and a state agency shall adopt rules under Sections
- 12 55.004(d) and 55.005, Occupations Code, as added by this Act, not
- 13 later than March 1, 2014.
- 14 SECTION 6. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2013.
