1 AN ACT 2 relating to the authority of a psychologist to delegate the provision of certain care to a person under the psychologist's 3 supervision, including a person training to become a psychologist. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Chapter 501, Occupations Code, is amended by 6 adding Subchapter H to read as follows: 7 SUBCHAPTER H. PRACTICE BY PSYCHOLOGIST 8 Sec. 501.351. GENERAL AUTHORITY TO DELEGATE. (a) 9 Α psychologist licensed under this chapter may delegate to a 10 provisionally licensed psychologist, a newly licensed psychologist 11 12 who is not eligible for managed care panels, a person who holds a temporary license issued under Section 501.263, and a person who 13 14 satisfies Section 501.255(a) and is in the process of acquiring the supervised experience required by Section 501.252(b)(2) any 15 16 psychological test or service that a reasonable and prudent psychologist could delegate within the scope of sound psychological 17 judgment if the psychologist determines that: 18 19 (1) the test or service can be properly and safely performed by the person; 20 21 (2) the person does not represent to the public that 22 the person is authorized to practice psychology; and 23 (3) the test or service will be performed in the 24 customary manner and in compliance with any other law.

- 1 (b) The delegating psychologist remains responsible for the
- 2 psychological test or service performed by the person to whom the
- 3 test or service is delegated, and the test or service is considered
- 4 to be delivered by the delegating psychologist for billing
- 5 purposes, including bills submitted to third-party payors. The
- 6 person must inform each patient on whom the test or service is
- 7 performed that the person is being supervised by a licensed
- 8 psychologist.
- 9 (c) The board may determine whether:
- 10 <u>(1) a psychological test or service may be properly</u>
- 11 and safely delegated under this section; and
- 12 (2) a delegated act constitutes the practice of
- 13 psychology under this chapter.
- 14 (d) A person who is a licensed psychologist and to whom
- 15 <u>another psychologist delegates a psychological test or service</u>
- 16 under this section may represent that the person is engaged in the
- 17 practice of psychology.
- 18 Sec. 501.352. PERFORMANCE OF DELEGATED ACT DOES NOT
- 19 CONSTITUTE PRACTICE OF PSYCHOLOGY. A person to whom a psychologist
- 20 delegates a psychological test or service under Section 501.351(a)
- 21 is not considered to be engaged in the independent practice of
- 22 psychology without a license issued under this chapter unless the
- 23 person acts with the knowledge that the delegation and the action
- 24 taken under the delegation violate this subtitle.
- 25 SECTION 2. This Act takes effect September 1, 2013.
