(a) No person may possess a finfish of any species taken from coastal water, except broadbill swordfish, shark, <u>or</u> [and] king mackerel, that has the head [or tail] removed unless the fish has been finally processed and delivered to the final destination or to a certified wholesale or retail dealer.
