- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 66.216, Parks and Wildlife Code, is
- 6 amended to read as follows:
- 7 Sec. 66.216. POSSESSION OF HEADED OR TAILED FISH. No person
- 8 may possess a finfish of any species taken from coastal water,
- 9 except broadbill swordfish or [, shark, and] king mackerel, that
- 10 has the head or tail removed unless the fish has been finally
- 11 processed and delivered to the final destination or to a certified
- 12 wholesale or retail dealer.
- SECTION 2. Subchapter C, Chapter 66, Parks and Wildlife
- 14 Code, is amended by adding Section 66.2161 to read as follows:
- Sec. 66.2161. SALE OR PURCHASE OF SHARK FINS. (a) In this
- 16 section:
- 17 <u>(1) "Shark" means any species of the subclass</u>
- 18 <u>Elasmobranchii.</u>
- 19 (2) "Shark fin" means the fresh and uncooked, or
- 20 cooked, frozen, dried, or otherwise processed, fin or tail of a
- 21 shark.
- (b) A person may not buy or offer to buy, sell or offer to
- 23 sell, possess for the purpose of sale, transport, or ship for the
- 24 purpose of sale, barter, or exchange a shark fin.

- 1 (c) Except as provided by Subsection (d), this section
- 2 applies to the possession, transportation, sale, or purchase of any
- 3 shark fin regardless of where the shark was taken or caught.
- 4 (d) This section does not apply to the possession or
- 5 transportation in this state of a shark fin taken or caught outside
- 6 this state and transported from a point outside this state by common
- 7 carrier without being unloaded in this state to a point of delivery
- 8 outside this state.
- 9 (e) Notwithstanding Subsection (b), the department may
- 10 issue a permit for the possession, transport, sale, or purchase of
- 11 shark fins for a bona fide scientific research purpose.
- 12 (f) When a person is charged with violating this section,
- 13 the warden or other peace officer shall seize and hold the shark fin
- 14 as evidence. Notwithstanding Section 12.109, on a final court
- 15 ruling, the department shall destroy the shark fin.
- 16 SECTION 3. Section 66.218, Parks and Wildlife Code, is
- 17 amended by adding Subsections (c) and (d) to read as follows:
- 18 (c) A person who violates Section 66.2161 or a proclamation
- 19 adopted under that section commits an offense that is a Class B
- 20 Parks and Wildlife Code misdemeanor.
- 21 (d) If it is shown at the trial for a violation of Section
- 22 66.2161 or a proclamation adopted under that section that the
- 23 defendant has been convicted within five years before the trial
- 24 date of a violation of that section, on conviction the defendant
- 25 shall be punished for a Class A Parks and Wildlife Code misdemeanor.
- 26 SECTION 4. The change in law made by this Act applies only
- 27 to an offense committed on or after the effective date of this Act.

H.B. No. 852

- 1 An offense committed before the effective date of this Act is
- 2 governed by the law in effect on the date the offense was committed,
- 3 and the former law is continued in effect for that purpose. For
- 4 purposes of this section, an offense was committed before the
- 5 effective date of this Act if any element of the offense occurred
- 6 before that date.
- 7 SECTION 5. This Act takes effect July 1, 2014.
