8	SECTION 1. Chapter 37, Education Code, is amended by adding
9	Subchapter A-1 to read as follows:
10	SUBCHAPTER A-1. PILOT PROGRAM IN DESIGNATED HIGH SCHOOLS IN
11	CERTAIN MUNICIPALITIES FOR ALTERNATIVE DISCIPLINARY PLACEMENT:
12	JUNIOR RESERVE OFFICERS' TRAINING CORPS (JROTC)
13	Sec. 37.031. ESTABLISHMENT OF PILOT PROGRAM. (a) A pilot
14	program is established under this subchapter for placement of high
15	school students in Junior Reserve Officers' Training Corps programs
16	as an alternative, in accordance with Section 37.032, to placement
17	in disciplinary alternative education programs or juvenile justice
18	alternative education programs.
19	(b) The pilot program applies only to a student enrolled in
20	<u>a high school:</u>
21	(1) located in a municipality that:
22	(A) has a population of 200,000 or more;
23	(B) is located on an international border; and
24	(C) has more than 20 percent of the population 18

1 to 24 years of age who have not graduated from high school, 2 according to the most recent American Community Survey five-year 3 estimates compiled by the United States Census Bureau; and 4 (2) designated by the agency under Subsection (c). 5 (c) The agency shall designate not more than two high schools that are located in a municipality described by Subsection 6 7 (b)(1) and that offer Junior Reserve Officers' Training Corps 8 programs to participate in the pilot program. The commissioner by rule shall adopt additional criteria that promote positive student 9 10 educational outcomes for the agency to use in making designations under this subchapter. 11 12 (d) The application of this subchapter to a student enrolled in a high school located in a municipality described by Subsection 13 (b)(1) is not affected if, after the high school is designated under 14 Subsection (c), the high school graduation rate in the municipality 15 16 changes and the municipality no longer meets the requirements of 17 Subsection (b)(1)(C). PARTICIPATION REQUIREMENTS AND EXCEPTIONS. 18 19 (a) Notwithstanding any other provision of Subchapter A and except as provided by Subsection (c), a student subject to this subchapter 20 who is otherwise required or permitted under Subchapter A to be 21 22 placed in a disciplinary alternative education program or juvenile justice alternative education program may, instead of that 23

(a) In addition to 18 19 the requirements for the student code of conduct under Section 37.001, the student code of conduct for a school district that 20 includes a school designated under Section 37.031(c) must, 21 22 consistent with this subchapter and as applied to the designated 23 school: 24 (1) specify conditions that authorize a principal or other appropriate administrator to require a student to participate 25 26 in a Junior Reserve Officers' Training Corps program; 27 (2) specify that consideration will be given, as a

No. 977 1 factor in each decision concerning participation in a Junior Reserve Officers' Training Corps program, to: 2 (A) se<u>lf-defense;</u> 3 4 (B) intent or lack of intent at the time the 5 student engaged in the conduct; (C) <u>a student's disciplinary history; or</u> 6 7 (D) a disability that substantially impairs the 8 student's capacity to appreciate the wrongfulness of the student's conduct; 9 10 (3) provide guidelines that promote positive student educational outcomes for determining placement in a Junior Reserve 11 12 Officers' Training Corps program as an alternative to placement in a disciplinary alternative education program or juvenile justice 13 14 alternative education program; 15 (4) provide guidelines for setting the length of a term of required participation in a Junior Reserve Officers' 16 17 Training Corps program; and (5) address the notification of a student's parent or 18 19 guardian of a violation of the student code of conduct committed by the student that results in required participation in a Junior 20 Reserve Officers' Training Corps program. 21 22 (b) This section does not require the student code of conduct to specify a minimum term of required participation in a 23 24 Junior Reserve Officers' Training Corps program. Sec. 37.034. DETERMINATION REGARDING CERTAIN CONDUCT. 25 26 Section 37.006(e) applies to this subchapter. Sec. 37.035. NOTICE TO PARENTS. (a) Not later than the 27

in a Junior Reserve Officers' Training Corps program as authorized 2 under this subchapter, the school district shall notify the 3 student's parent or guardian of the student's placement. The notice 4 5 must include the reason for the placement. 6 (b) A noncustodial parent may request in writing that a 7 school district or school, for the remainder of the school year in 8 which the request is received, provide that parent with a copy of any written notification relating to the student's placement as 9 10 authorized under this subchapter that is generally provided by the district or school to a student's parent or guardian. 11 12 Sec. 37.036. TERM OF PLACEMENT. (a) The board of trustees of the school district or the board's designee shall set a term for 13 a student's required participation in a Junior Reserve Officers' 14 Training Corps program as authorized under this subchapter. The 15 16 term must be for a period consistent with the guidelines adopted 17 under the student code of conduct in accordance with Section 37.033(a)(4). If the period of placement is inconsistent with the 18 19 guidelines adopted under the student code of conduct, the notice under Section 37.035(a) must provide an explanation of the 20 21 inconsistency. 22 (b) Before a student may be required to participate in a Junior Reserve Officers' Training Corps program as authorized under 23 24 this subchapter for a period that extends beyond the end of a school

(a)</u> 24 <u>If a student required to participate in a Junior Reserve Officers'</u> 25 <u>Training Corps program as authorized under this subchapter enrolls</u> 26 <u>in another school district before the expiration of the period of</u> 27 <u>required participation, the board of trustees of the school</u>

1 district requiring the participation shall provide to the district in which the student enrolls, at the same time other records of the 2 3 student are provided, a copy of the placement order. The district in which the student enrolls shall inform each educator who will 4 5 have responsibility for, or will be under the direction and supervision of an educator who will have responsibility for, the 6 7 instruction of the student of the contents of the placement order. 8 (b) Each educator shall keep the information received under this section confidential from any person not entitled to the 9 10 information under this section, except that the educator may share the information with the student's parent or guardian as provided 11 12 for by state or federal law. (c) Subject to Subsection (d), the school district in which 13 the student enrolls may continue the Junior Reserve Officers' 14 Training Corps program placement under the terms of the order or may 15 16 allow the student to attend regular classes without completing the period of required participation. 17 18 (d) If the school the student attends in the school district 19 in which the student enrolls does not offer a Junior Reserve Officers' Training Corps program, the student may be placed in a 20 disciplinary alternative education program or a juvenile justice 21 22 alternative education program under the procedures provided by this subchapter for the remainder of the term set under Section 37.036. 23 24 Sec. 37.040. PROCEDURE FOR ADDRESSING SUBSEQUENT CONDUCT 25 AFTER PROGRAM PARTICIPATION. A student required to participate in 26 a Junior Reserve Officers' Training Corps program as authorized

under this subchapter is subject to the provisions of Subchapter A

1 relating to removal from class and placement in a disciplinary alternative education program or juvenile justice alternative 2 education program if the student, after completion of any required 3 participation in a Junior Reserve Officers' Training Corps program 4 5 as authorized under this subchapter, engages in subsequent conduct requiring or permitting the student to be removed from class and 6 7 placed in a disciplinary alternative education program or juvenile 8 justice alternative education program under Subchapter A. 9 Sec. 37.041. ## 21 SECTION 2. Section 37.020, Education Code, is amended by 22 adding Subsections (d) and (e) to read as follows:

26 (1) information identifying the student, including 27 the student's race, sex, and date of birth, that will enable the

1 agency to compare placement data with information collected through 2 other reports; 3 (2) information indicating whether the placement was 4 based on: 5 (A) conduct violating the student code of conduct adopted\_under Section 37.001; 6 7 (B) conduct for which placement in a disciplinary alternative education program or juvenile justice alternative 8 education program is otherwise required or permitted by this 9 10 subchapter; or (C) conduct occurring while a student was 11 12 enrolled in another district and for which placement in a Junior Reserve Officers' Training Corps program is permitted by Section 13 14 37.039; 15 (3) the number of full or partial days the student was assigned to the program and the number of full or partial days the 16 17 student attended the program; (4) the number of placements that were inconsistent 18 19 with the guidelines included in the student code of conduct under 20 Section 37.033(a)(4); 21 (5) information regarding the academic performance of the student on assessment instruments required under Section 22 39.023(a), as applicable, during the year preceding, during the 23 24 year of, and during the year following placement in the program, to the extent available; and 25 26 (6) information indicating whether the student dropped out of school, to the extent available. 27

## (e) Subsection (d) and this subsection expire September 1, 2 2015.

3 SECTION 3. (a) Not later than December 1, 2013, the 4 commissioner of education shall adopt rules for the Texas Education 5 Agency to use to designate public high schools to participate in the 6 pilot program established under Subchapter A-1, Chapter 37, 7 Education Code, as added by this Act.

8 (b) Not later than January 1, 2014, the Texas Education 9 Agency shall designate not more than two public high schools to 10 participate in the pilot program established under Subchapter A-1, 11 Chapter 37, Education Code, as added by this Act.

(c) The pilot program established under Subchapter A-1, Chapter 37, Education Code, as added by this Act, shall be implemented in each high school designated under that subchapter beginning with the spring semester of the 2013-2014 school year.

16 SECTION 4. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2013.
