4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 533, Government Code, is
6	amended by adding Section 533.00281 to read as follows:
7	Sec. 533.00281. REVIEW PROCESS FOR STAR + PLUS MEDICAID
8	MANAGED CARE ORGANIZATIONS. (a) The commission's office of
9	contract management shall establish an annual review process for
10	managed care organizations participating in the STAR + PLUS
11	Medicaid managed care program. The office shall determine the
12	topics to be examined in the review process, except that the review
13	process must include a thorough investigation of each managed care
14	organization's procedures for determining whether a recipient
15	should be enrolled in the STAR + PLUS home and community-based
16	services and supports (HCBS) program, including the conduct of
17	functional assessments for that purpose and records relating to
18	those assessments.
19	(b) The office of contract management shall use the review
20	process to review each fiscal year:
21	(1) every managed care organization participating in

- 3 (c) Notwithstanding Subsection (b), during the state fiscal
- 4 biennium ending August 31, 2015, the office of contract management
- 5 shall use the review process to review every managed care

- 7 program. This subsection expires September 1, 2016.
- 8 (d) In conjunction with the commission's office of contract
- 9 management, the commission shall provide a report to the standing
- 10 committees of the senate and house of representatives with
- 11 jurisdiction over the Medicaid program not later than December 1 of
- 12 each year. The report must:
- 13 (1) summarize the results of the reviews conducted
- 14 under this section during the preceding fiscal year;
- 15 (2) provide analysis of errors committed by each
- 16 <u>reviewed managed care organization; and</u>
- 17 (3) extrapolate those findings and make
- 18 recommendations for improving the efficiency of the program.
- 19 SECTION 2. The Health and Human Services Commission shall
- 20 provide the first report required by Section 533.00281(d),
- 21 Government Code, as added by this Act, not later than December 1,
- 22 2014.
- 23 SECTION 3. If before implementing any provision of this Act
- 24 a state agency determines that a waiver or authorization from a
- 25 federal agency is necessary for implementation of that provision,
- 26 the agency affected by the provision shall request the waiver or
- 27 authorization and may delay implementing that provision until the

- 1 waiver or authorization is granted.
- 2 SECTION 4. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2013.
