- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. (a) In this Act:
- 6 (1) "Commission" means the Texas Animal Health
- 7 Commission.
- 8 (2) "Department" means the Department of State Health
- 9 Services.
- 10 (b) The commission shall conduct a study regarding the
- 11 current risk level for bovine tuberculosis, as determined
- 12 epidemiologically and defined by rule of the commission, in areas
- 13 of this state determined by the commission by rule to be infected
- 14 with or at high risk for bovine tuberculosis.
- 15 (c) Not later than September 1, 2014, the commission shall
- 16 submit a report regarding the results of the study to the Department
- 17 of Agriculture, the governor, the lieutenant governor, the House
- 18 Committee on Agriculture and Livestock, the Senate Committee on
- 19 Agriculture, Rural Affairs, and Homeland Security, the House
- 20 Committee on Public Health, and the Senate Committee on Health and
- 21 Human Services. The report must include:
- 22 (1) to the extent possible, an assessment of the risk
- 23 level for bovine tuberculosis presented by areas in Mexico
- 24 bordering this state;

- 1 (2) to the extent possible, a description of the
- 2 efforts taken by the Ministry of Agriculture, Livestock, Rural
- 3 Development, Fisheries and Food and other agencies of the United
- 4 Mexican States to eliminate bovine tuberculosis in the state of
- 5 Chihuahua and other areas;
- 6 (3) a description of the current practices adopted by
- 7 the United States Department of Agriculture and the commission to
- 8 eliminate bovine tuberculosis;
- 9 (4) an assessment of the risk level for bovine
- 10 tuberculosis for the state if dairy farming were to occur in areas
- 11 determined by the commission by rule to be infected with or at high
- 12 risk for bovine tuberculosis; and
- 13 (5) an assessment of whether the areas determined by
- 14 the commission by rule to be infected with or at high risk for
- 15 bovine tuberculosis could be decreased in size.
- 16 (d) As soon as practicable, the commission shall present the
- 17 report regarding the results of the study at an open meeting of the
- 18 commission.
- 19 (e) This Act expires October 1, 2014.
- 20 SECTION 2. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2013.
